JUSTICE B.C. SAKSENA, V.C

This bunch of 73 cases in all involve almost identical questions of fact and law and reliefs also. O.A. 83 of 1992 is being treated as the leading O.A. The number of days of working varies in each of the O.A and broadly the period of working of the applicants as Volunteer Ticket collectors ranges between 5 to 18 days and that too on the allegations made by the applicants in the month of January 1982.

2. The applicants alleged that they had worked for the period indicated by them in the various O.As, in the month of January 1982 @ Rs.15/- per day. The applicants allege that on the basis of Railway Board's letter dated 6.2.90 they made representation regarding their re-engagement as Volunteer Ticket Collectors since they had worked prior to 17.11.86.

3. Reliance for the claim is based on the decisions of this Tribunal as also the P.B. in a few O.As preferred

by persons similarly circumstanced. The applicants, therefore, have sought a relief for a direction to the respondents to re-engage the applicants as Volunteer Ticket Collectors or Mobile Booking Clerks as per Extant Rules. They have also in some petitions prayed that a direction be issued to the respondents to take the petitioners on duty and pay back wages from 10.12.90 till the date when they first presented themselves for engagement.

4. The respondents have resisted the petition and have filed a counter affidavit as also a supplementary counter affidavit.

5. The applicants have filed a rejoinder affidavit. The applicants have admittedly not re-engaged after their short stint ranging between 5 to 18 days in the month of January 1982. The Railway Board's circulars dated 6.2.90 is annexed as Annexure A1 to the leading O.A and have also been annexed in ~~xxx~~ some of the O.As. A perusal of the said letter shows that in the light of the judgment dated 26.8.87 of the Central Administrative Tribunal, Principal Bench, New Delhi in O.A. No. 1174 of 1984 (Neera Mehta and Ors Vs. Union of India and Ors) and dismissal of the SLP No. 14613/87 by the Hon'ble Supreme Court on 7.9.89. The Railway Board has decided that the 'cut off' date for being considered for absorption in regular employment against regular vacancies earlier provided to be 14.8.81 will be substituted by 17.11.86 Paragraph 3 of the circular letter is the anchor sheet for the claim in the present O.A which reads as under:-

" In regard to candidates engaged as Mobile Booking Clerks discharged consequent on discontinuance of the scheme by zonal Railways, as a result of ^{Board's} ~~6000~~ letter dated 17.11.86 or any earlier instruction to the same effect may be re-engaged as Mobile Booking Clerks as and when they approach the Railway Administration in regular employment may be considered after they complete 3 years of service as Mobile Booking Clerks in the same manner as in the case of other Mobile Booking Clerks covered under para 1. "

6. In paragraph 1 attention was invited to Railway Board's letter dated 21.4.92 and the 'cut off date' provided therein was 14.8.81.

7. We have heard the learned counsel for the parties.

8. Shri B.B. Paul, counsel appearing for the respondents raised a preliminary objection that the O.As are barred by time, laches and acquiescence.

9. The learned counsel urged that the applicants have not been engaged after January 1982. He further submitted that the Railway Board's letter dated 6.2.1990 does not govern the applicants who alleged to have worked for a period between 5 to 18 days as Volunteer Ticket Collectors. He further submitted that the applicants were not discharged consequent to discontinuance of the scheme by the zonal Railways as a result of the Board's letter dated 17.11.86. Their discontinuance had taken place four

Bcl

years earlier and not on the basis of the Railway Board's said letter.

10. The respondents have also disputed the correctness of the averment made by the applicants about their having worked for the duration indicated by them in each of the O.As. The applicants in support of their assertion of having worked in the year 1982 for a number of days indicated by them during the 'Kumbh mela' have been annexed, copy of a certificate stated to have been issued by one Ram Das who has given out his designation as ^{Head} Ticket Collector AKM, N. Rly Allahabad. Copy of such a certificate has been annexed as Annexures A-3 and A-4 to the leading O.A. Shri B.B. Paul submitted that Shri Ram Das was not competent to issue this certificate and the said certificate cannot be treated as proof of the working period of the applicants indicated in the certificates. We, however, feel that it would not be necessary to enter into this controversy for the purposes of deciding the O.As. We, proceed to decide the O.A in the light of the claim based on the provisions of the Railway Board's circular letter dated 6.2.90. We, however, make it clear that we may not be understood to have accepted the claim of the applicants with regard to the days of their working. We may take up the plea of the O.As being barred by limitation. Admittedly, none of the applicants initiated any ^{judicial} ~~civil~~ proceedings in any court to challenge their discontinuance made in January 1982. The Central Administrative Tribunal was constituted in November 1985. These O.As have been preferred in the year 1992.

11. As noted hereinabove, the basis for the claim apart from the provisions of the Railway Board's letter dated 6.2.90 is certain decisions rendered by this Bench

of the Tribunal. The said O.As are O.A. No. 722/90 Rajendra Kumar Srivastava Vs. Union of India and Ors, C.A No. 471/80 Mukesh Kumar Srivastava Vs. Union of India and Ors, O.A. No. 648/91 Madan Mohan Pandey Vs. Union of India and Ors. No doubt, in these cases orders for re-engagement of the applicants therein had been passed. On the material placed in the supplementary affidavit we find subsequently in several other cases decided by this Bench of the Tribunal, a different view was taken when it was pointed out that the Railway Board's circular applied to Mobile Booking clerks and the decision in Neera Mehta's case was in respect to Mobile Booking Clerks. This distinction was noted while allowing a few review petitions in some O.As and in O.A. No. 131/92 Lalji Shukla and Ors, the only direction given was that the respondents may consider and analyse the cases of Mobile Booking Clerks and find out if any scheme can be framed by them laying down a particular criteria for re-engaging them on casual or daily basis. Against this decision, the Railway Authorities preferred an SLP before the Hon. Supreme court and the Hon. Supreme court by an order dated 7.4.94 passed the following order:-

" Delay condoned. The order only gives a direction to the petitioner to find out any scheme can be framed. The Union of India can examine the matter and if it is not possible to frame a scheme, record its finding accordingly. There is no obligation cast by the impugned order that the scheme should be framed in any case subject to the above observations the SLP is disposed of".

~~above observations of the special leave petition is disposed of~~

Subsequently, the Railway Administration considered the possibility of framing a scheme in the light of the directions given in Lalji Shukla's case by the Bench of this Tribunal which was also repeated in some other OAs which came for decision subsequent to the decision in Lalji Shukla's case.

12. The Railway Administration in the supplementary counter affidavit have indicated that they have taken a decision that no scheme can be framed for Volunteer Ticket Collectors for absorption and regularisation in group 'C' category posts since this would militate^{ed} against the statutory provisions laid down for Recruitment of Ticket Collectors etc as contained in para 127 of Section B of Chapter I of the Indian Railway Establishment Manual 1989 Edition. They have further taken the view that no such posts or vacancies exists on the Railways for Volunteer Ticket Collectors/Mobile Booking Clerks for their re-engagement on casual or daily basis.

13. It was also held that re-engagement will burden the public exchequer and will also enlarge backdoor entry and will affect reservation policy as contained in Article 16(4) of the Constitution of India. It was also held that framing of such a scheme for those Volunteers who have clearly worked for a period of merely for 5 to 18 days will be against public interest as the posts filled up by them are generally by direct recruitment through the Railway Recruitment Board open for general competition and the eligible persons at large would be deprived of their legitimate rights.

14. Admittedly, this scheme has been given up after 17.11.86 and the Railway Administration has for cogent reasons indicated that it was not feasible to draw up a scheme as required in orders passed in various O.A.s

15. Shri B.B. Paul has also invited our attention to certain decisions in review petitions which were allowed. ~~On the basis of an analogy of the decision by the Principal Bench in 'Neera Mehta's case direction for re-engagement had been passed in the O.A.s. While deciding allowing the review petitions it was noted that the decision in Neera Mehta's case was confined to Mobile Booking Clerks and there is no parity between Mobile Booking Clerks and Volunteer Ticket Collectors. The present applicants fall in the later category.~~

16. Quite a large number of decisions have been rendered from time to time and the view taken in the earlier decisions have been washed down or even not accepted in later decisions and a direction to draw up a scheme was only provided as in Lalji Shukla's case (Supra), which was followed in many other subsequent decisions. The turns and twists which have taken place in the view expressed on the question have been referred to show that the decisions of this Bench of the Tribunal on the basis of which the applicants ^{are} claiming similar benefit being extended to them do not hold the field.

17. We may now take up for consideration the plea of the applicants that the ^{benefit of the} decisions in some O.As in favour of similarly situated persons may be extended to the applicants. It is now fairly well settled that the judgment of the Tribunal

for that matter of any court does not give rise to a cause of action. It is the orders of the authority concerned or their inaction which give rise to the grievance and the cause of action based upon this has to be considered for purposes of determining whether the petition is barred by time under the provisions of Sec. 21 of the Administrative Tribunals Act.

18. As was noted by the Madras Bench of the Central Administrative Tribunal in a decision reported in (1994) 28 ATC pg. 20 'Tamil Nadu Divisional Accountants Association and Ors. Vs. Union of India and Ors, this position of law has been clearly affirmed in the judgment of the Supreme court in 'Bhoop Singh Vs. Union of India and Ors. (1992) 21ATC page 675. Before the Madras Bench the question of delay was raised and it held that since the delay has not been satisfactorily explained the O.A was rejected on the ground of limitation alone. In that case an order adverse to the applicants was passed on 14.10.86. A decision on a similar order was rendered by the Chandigarh Bench of the Tribunal on 1.5.91. There after the applicants Association moved in the matter and made a representation. 5 years delay was held as fatal.

19. A Full Bench of the Ernakulam Bench of the Tribunal in a decision reported in (1994) 28 ATC 177 has also taken the view that decisions in similar cases cannot give a fresh cause of action and the period must be counted from the date the claim relates.

20. The Hon'ble Supreme Court in 'Bhooop Singh Vs. Union of India and Ors (Supra) had inter alia, held that "inordinate and unexplained delay and laches by itself/^{is} a good ground to refuse relief to the petitioner irrespective of the merit of his claim. It was also observed that Art. 14 or the principle of non-discrimination is equitable principle. Therefore, any relief claimed on that basis must itself be founded on equity and not be alien to that concept".

21. We may also refer to a relevant observation made in a recent decision of Hon. Supreme Court in 'Ratan Chandra Samant and Ors. Vs. Union of India and Ors reported in 1994 S.C.C(L&S) page 182. The petitioners before the Supreme Court in that case were casual labourers of south eastern Railway. They were alleged to have been appointed between 1964-69 and represented between 1975-78. They, through their petition sought a direction to be issued to the opp. parties to include their names in Live Casual Labourers Register after due screening and to give them re-employment according to their seniority. The basis for the claim amongst others ~~and~~ was a few judgments rendered by the Apex court in 1985 and 1987 directing the Railway Authorities to prepare a scheme and to absorb the casual labourers in accordance with their seniority. The petitioners appeared to have made a representation in 1990 to the Authorities in which it was alleged that they are not following the orders of the Supreme court, High court of Calcutta and Calcutta Bench of the C.A.T. In the facts of the said case the Hon. Supreme Court, took the view that since no explanation has been given as to why the petitioners did not approach till 1990 held that two questions arise;

- (i) whether the petitioners/^{are}entitled as a matter of right to reemployment.
- (ii) whether they have lost their right, if any, due to delay.

22. While dealing with the said question the following observation was made:-

" Delay itself deprives a person of his remedy available in law. In absence of any fresh cause of action or any legislation a person who has lost his remedy by lapse of time loses his right as well".

23. A Full Bench of the Tribunal(PE, while deciding O.As 767 and 842 of 1989 made the following relevant observation:-

" It is not opened to court of record to pass an order in respect of persons who are not even present before it by any application or petition. In this view of the matter the view taken in the case of one or more employee by a judicial forum cannot be ipso facto made applicable to all other employees in the same cadre, rank or situation by another judicial forum."

This observation also supports the view taken hereinabove that the judgment in a case does not give a cause of action to another employee,^{who}claims to be similarly circumstanced as the applicant in other case earlier decided.

24. Shri B.B. Paul, learned counsel appearing for the respondents have invited our attention to a decision rendered by the Principal Bench in 'Ashish Chakraborty Vs. Union of India and Ors, reported in 1994(1) ATJ 382. In the said case the facts are almost identical as in the case in hand. The applicant alleged that he was engaged as Mobile Booking Clerk from 1.6.85 to 15.7.85 and had not been engaged thereafter. He made a representation stating that he has worked for 32 days in 1985 and in view of the circular of the Railway Board dated 21.5.92 he be also considered for absorption as Mobile Booking Clerk. The applicant's representation was rejected and he was informed that he cannot be absorbed in terms of the letter dated 12.8.92. In the said case the applicant based his claim on the basis of a decision of the P.B. in a similar bunch of the cases. The Division Bench took the view that there is no parity or similarity between the applicants case and the applicants in the bunch of cases decided earlier. It was held that since the services of the applicant was not discontinued as a result of Railway Board's letter dated 17.11.86, the applicant's case was ~~not~~ not covered by para 3 of the Railway Board's letter dated 6.2.90. Since he was not discharged consequent upon discontinuance of the scheme by the zonal Railway as a result of letter dated 17.11.86. The same situation obtains herein also and we have already held accordingly.

25. In the said case, referring to the decision of the Supreme court in 'Bhoop Singh Vs. Union of India and Ors (Supra), the question of delay was also

considered and it was held that the petition was barred by limitation, the cause of action having accrued in July 1985. The said O.A was filed sometime in the year 1993.

26. The learned counsel for the respondents also invited our attention to another decision rendered by the same Division Bench of the Principal Bench in 'Anil Babu Sharma Vs. Union of India and Ors reported in 1994(1) ATJ pg-84.

27. The petitions before us are clearly barred by limitation as provided in Sec. 21 of the Administrative Tribunals Act. The provisions of the Railway Board's letter dated 6.2.90 is not attracted and applicable to the applicants.

28. Admittedly, the scheme has been given up since after 17.11.86 and is no longer in force. This fact cannot be lost sight of. The applicants therefore, cannot be granted ^{the} relief ~~sprayed~~ for by them. The applicants also raised a plea that one Shri R.N. Shorey and 12 Others Volunteer Ticket Collectors have been included in the approved list of 1982. It is, therefore, pleaded that the respondents have been given re-engagement to some Volunteers as Volunteer Ticket Collectors on Pick and Choose basis.

29. In the counter affidavit, it has been indicated that the 12 persons named in para 4.10 of the leading O.A had been re-engaged as Mobile Booking Clerks and not as Volunteer Ticket Collectors. The allegation, therefore, has been denied. Be that as it may, the applicants would be entitled to the relief claimed by them only if it is based on any statutory provision. The act of the respondents in re-engaging a few which has been satisfactorily

explained will not give rise to discriminatory treatment. The applicants in effect are seeking re-engagement on the strength of having worked for a period ranging between 5 to 18 days, which also is doubtful, and has been disputed by the respondents.

31. In view of the discussion hereinabove, on a totality of the circumstances we are not persuaded to grant the reliefs claimed for by the applicants. The O.As lack merit and ~~are~~ accordingly dismissed. No order as to costs. ^{Rel}

32. The copy of the judgment shall be placed on each of the O.As which have been decided by this common judgment.
