Hon'ble Mr. Justice S.K.Dhaon, V.C. .

The applicant came to this tribunal when he was transferred from Bhatpar Rani, Distt. Deoria to Raja Bazar Khadda.

2. The basis of the applicant^{tion} is that while posting at Bhatpur Rani, he was doing the job of Saving Bank Postal Assistant and there he was getting Rs.60/- per month in addition to his pay due to ~~passing~~ of an incentive bonus Scheme. He ^{is being} was posted at Raja Bazar Khadda as Postal Assistant. Therefore, there could be a loss of Rs.60/- p.m.

3. Km.Sadhana Srivastava, on behalf of the respondents, states that from November, 1992, the applicant has been re-transferred to Bhatpur Rani. This ~~again~~ should have rendered the application as infructuous. I make it clear that there ^{will be} is no loss in the emoluments of the applicant, in view of the order passed in November, 1992.

4. With these observations, the application stands disposed of finally^{final} without any order as to costs.

affirm and state on oath as under:-

1. That the deponent is the sole petitioner and as such he is fully acquainted with the facts deposed to below.

2. That the deponent was transferred from the post of S.B. Postal Assistant to Postal Assistant Bhatpar Rani to R.B. Khadda causing a monetary loss of Rs.60 P.M. Being aggrieved the applicant approached the Hon'ble Tribunal and the Transfer order was stayed.

3. That in spite of the service of the Stay order, the deponent was not allowed to work and he was forcibly relieved by the Sub Post Master Bhatpar Rani. Hence the stay order was not complied with by the concerned authorities and hence the applicants filed contempt petition (Vide C C A No. 1354/1992) against the concerned authorities who had committed the contempt willingly and intentionally of the order of the Hon'ble Tribunal and notices

have also been is sued against them.

4. That in the meantime the contemner no.2. i.e. Sri S.P. .O's Deoria Shri Ram Krishna Adrya, was transferred from Deoria to Azamgarh and new incumbent a had Joined vice him.

5. That when the new S S P O's Deoria, joined at Deoria, he passed an order dated 18.11.92, that the applicant will retain at Bhattpar Rani which is reproduced as under.

6. That in compliance of the order dated 18.11.1992 of S.S.P.O. Deoria, the Sub- Post Master Bhatpar Rani allowed the applicant work as treasurer at Bhatpar Rani and the charge of treasurer was handed over to the applicant by Shri Hari Shanker Prasad on 18.11.1992.

7. That since the applicant was not getting salary from the month of July 1992 to till date and his ~~children~~ children were suffering from Starvation he joined the post of treasurer at Bhat par Rani and immediately thereafter he sent a telegram on 20.11.1992 and a representation on 21.11.1992 to Sri Sr. S.P. Os Deoria by registered post no.2771 and its copy was also sent to the sub-Post Master Bhatpar Rani on the same day by registered post no.2791 against his arbitrary and illegal action .

A Photo copy of the telegram dated 20.11.1992 and representation dated 21.11.1992 are filed as Annexure 'III' & 'IV' to this affidavit.

8. That S..P.M. Bhatpar Rani named Sri Triveni Tripathi has posted his real brother Shri Gopal Tiwari as S.B. P.A. at Bhatpar Rani since the date of transfer of the applicant though he had not passed

the incentive Bonus Scheme and (examination) even though he was already posted as treasurer at Bhatpar Rani but Sri Gopal Tiwari is officiating against the post of S.B.P.A. by the arbitrary order and action of the S.P.A. Shri Triveni Tripathi. Hence the sub-Post Master, Shri Triveni Tripathi has committed another contempt of this Hon'ble Tribunal for which he is liable to be severely punished.

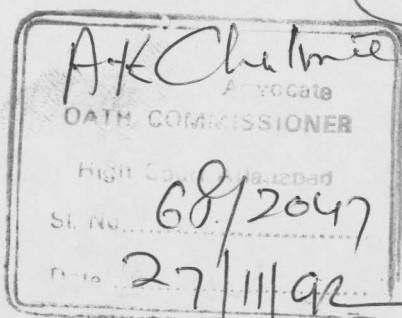
