ORDER (ORAL)

The applicants have filed this O.A. for restraining the respondents from considering and granting promotion <sup>from</sup> PWI grade Rs. 2000-3200/- to P.W.L Grade Rs. 2375-3500/- on the basis of the combind impugned seniority list dated 5.10.1993 (Annexure A-1 to the O.A.).

2. We have heard the arguments of Sri ~~L.M. Singh~~  
~~K.C. Singh~~ <sup>Mr</sup> for the applicant and Sri S.K. Misra proxy counsel for Sri V.K. Goel for the respondents.

3. We find from para 23 of the Counter reply that the impugned combind seniority list issued by the General Manager (P)'s letter dated 5.10.93 was treated as cancelled and withdrawn vide General Manager (P)'s letter dated 15.12.93. Thus, the seniority list dated 5.10.93 does not exist at all.

4. In view of this fact, the case of the applicants have become infructuous. The O.A. is dismissed as infructuous. No costs.
