
On behalf of the respondents the counter affidavit was filed. Time to file rejoinder affidavit had been granted, but since the rejoinder was not filed within time by the order passed on 15.1.97 the applicant was stopped from filing rejoinder. The matter has come up for admission today.

2. Shri V.K. Goel learned counsel for the respondents invited our attention to a Supreme court decision copy of which has been annexed as Annexure C.A. 1 alongwith the counter affidavit. The question considered by the Hon'ble Supreme court in the said decision was wholly identical to the question raised in the present O.A. The applicants who are working as Ministerial and Class IV employees in the Mechanical Department Primary Co-operative Bank Ltd, North Eastern Railway, Gorakhpur have through the O.A. claimed that they should be treated as regular railway servants.

For this the applicants have placed reliance on a decision of the C.A.T Hyderabad and the Madras Bench of the C.A.T. Both these decisions have been considered by the Hon'ble Supreme court and have been held not to be ~~laying~~^{laying} down correct law. The Hon'ble Supreme court in the said decision has held that in view of the provisions of the Co-Operative societies Act under which the societies have been registered does not ~~provide~~^{clothe} the employees working in the Co-Operative Societies with the status of regular railway servants.

3. In view of the above the O.A. lacks merit and is dismissed accordingly.
