O R D E R ( Oral )

By Hon'ble Mr. Justice R.R.K. Trivedi, V.C.

By this O.A. filed under Section 19 of the Administrative Tribunals Act, 1985, the applicants who are 115 in number have prayed for direction to the respondents to give benefit of the orders passed by Calcutta Bench of this Tribunal on 30.10.1987 (annexure A-1) and the Judgment dated 25.06.1993 (annexure A-4) passed by this Tribunal and implement the same so far as the applicants no.1 to 27 are concerned and also other similarly situated employees. The applicants have also prayed for direction to the respondents to implement the IVth Pay Commission report in respect of the applicants no.28 to 115 taking into consideration the pay scale of the applicants fixed by the Expert Classification Committee(i.e. E.C.C.)

2. Counter-affidavit and rejoinder-affidavits have been exchanged. The applicants filed a suppl. affidavit on 01.11.2002 annexing therewith the copy of the order passed in October, 1985, which is with regard to Fitment of Industrial Workers in the P/V scale recommended by the IIIrd Pay Commission. The categories covered by the order are;

- a : Armourers
- b : Electrician (MV)
- c : Machinist D
- d : Millwright
- e : Precision Grinders

Para 4 of this order concludes as under;

"That matter has now been further clarified and army H.Q. have stated that the pay of trademan of above said categories be fixed in the revised scale i.e. 330-480 from 16 October, 1981 i.e. the date of issue of Govt. order. The pay of tradesman who have -been promoted to Highly Skilled Grade I consequent to implementation of three grade structure be refixed under Article 156A CSR."


3. Leanned counsel for the applicants submits that the aforesaid order satisfies the demands of the applicants made through this O.A. It is also submitted that this order could not be filed before this Tribunal as it was not in their knowledge. Shri P. Mathur submitted that the order was passed in 1985 whereas this O.A. has been filed on 21.03.95, there is a long gap between two dates and it is difficult to say at this stage as to whether the applicants were granted benefit of the order passed in 1985 or not. It requires thorough examination of the records and for this purpose the applicants will have to make a representation for claiming benefit of the order <sup>notified</sup> ~~passed~~ alongwith the affidavit.

4. We have carefully considered the submissions made by the counsel for the parties and we are of the opinion that as the applicants are satisfied with the order (S.A.-1) of October, 1985, it is no more necessary to examine the claims and counter-claims raised in this O.A. The ends of justice will be served if the respondents are directed to examine the claim of the applicants as to whether they were granted the benefit of the order or not. If the applicants were not granted

the benefit, they will be entitled for the benefit from the date it should have been granted to them. The application is accordingly disposed of finally with the liberty to the applicants to make representation through proper channel alongwith copy of this order and annexing therewith the copy of the order filed as annexure S.A.-1. The claim shall be then considered by the respondent no.2 in accordance with rules and decided by a reasoned and speaking order within 4 months from the date <sup>of</sup> a copy of this order is filed. No order as to costs.
