O R D E R (ORAL)

BY MR. JUSTICE R.R.K. TRIVEDI, V.C.

By this O.A., the applicants have claimed Dearness Allowance on the family pension. The applicants are widows of Ex-Railway employees, who have been given compassionate appointment and they are also getting family pension. They claim Dearness Allowance on the family pension, which have been denied, aggrieved by which the applicants have approached this tribunal.

2. ~~THE question in the~~ The facts of the case have been considered by the



Hon'ble Supreme Court in case of Union of India & others Vs. G. Vasudevan Pillay & others (1995) 29 ATC 180. Hon'ble Supreme Court has held that the denial of Dearness relief on pension/family pension in cases of those ex-service men, who got re-employment or whose dependents have got re-employment is legal and just. The decision to reduce the enhanced pension from pay of those ex-servicemen only who were holding civil posts on 1.1.1986 following their re-employment is, however, unconstitutional. The present case is squarely covered by the view^u expressed by the Hon'ble Supreme Court that Dearness relief on family pension in case of those who got re-employment has rightly been refused. Thus, the applicants are not entitled for any relief. Accordingly, the O.A. is dismissed.

No order as to costs.
