O R D E R

HON'BLE MR. JUSTICE R.R.K. TRIVEDI, VICE-CHAIRMAN

By this O.A. under Section 19 of Administrative Tribunals Act 1985, the applicants have prayed for a direction to the respondents to give scale of Rs.425-700/- to the applicants which is equivalent to the pay scale of Draftsman Grade-II of the Central Public Works Department notionally with effect from 13.05.1982 and actually with effect from 01.11.1983 with consequential benefits, as awarded by Jabalpur Bench of this Tribunal in T.A. No.111 of 1986 and O.A. No.87 of 1986, O.A. No.246 of 1988 ^{which} and has been confirmed by the Hon'ble Supreme Court.

2. Learned counsel for the respondents has submitted that reliefs claimed in this O.A. have been granted to the applicants by the respondents under order of Ministry of Defence, uniformly throughout country. For this purpose Shri Ashok



Mohiley, learned counsel for the respondents invited our attention to the Supplementary Affidavit filed on 24.10.1997 in para 12 whereof it has been stated that the orders issued by the Ministry of Defence dated 01.07.1996 were in-compliance of the judgement of the Hon'ble Supreme Court Dated 20.07.1995 in Civil Appeal No.1433 of 1995 and Civil Appeal Nos.2124-33/1993, SLP (C)No.8393-94/87/22016/93, and Review petitions nos.857-58/91. Thus, the correct scale has been paid to all the applicants and in the circumstances the O.A. has been rendered infructuous, the O.A. is accordingly dismissed as infructuous.

3. There will be no order as to costs.
