Order (In open court)

(By Hon'ble Mr. S. Dayal Member (A))

In this bunch of O.As., the applicants have filed application against the transfer orders issued posting them in various grades as Senior Divisional Accounts Officer or Divisional Accountants in three grades to divisions in the State. The applicants have prayed for cancellation of transfer orders on various grounds.

2. Sri R.P. Singh, Sri Siddharth Srivastava  
Sri Rakesh Verma : Sri K.S. Rathore and Sri A.V.  
Srivastava appeared for the applicants and Sri Amit  
Sthalekar for respondents No. 1 to 3 and Sri K.P.  
Singh for respondent No.4 appeared. Their arguments  
have been heard. We had called for certain record



from the Office of Accountant General. That has also been taken into consideration.

3. While the O.As. were under consideration a Notification of Election Commission dated 12.7.99 was issued in which the Election Commission had directed that there would be a total ban on the transfer of all officers/officials connected with the conduct of Elections. It has also been mentioned in this Notification that the transfer orders issued in respect of the above category of officers prior to the date of announcement but not implemented till date should not be given effect without obtaining specific permission from Election Commission of India in this regard. The net effect of this Notification is that the transfers have been put on hold till the Election process is completed because the officers concerned are officials concerned who are involved in the Election process as Presiding Officers and Polling Officers etc.

4. The learned counsels for the respondents have not shown any permission of the Election Commission hence averments of the learned counsel for the applicants are that the applicants are still performing their duties on the posts which were held previously by them.

5. We, therefore, direct that the orders of transfer of the applicants may not be implemented till election process is over. In the meanwhile the respondents shall consider representations of the applicants if made within two weeks from the

date of this order and shall pass a reasoned order on the representations with regard to their transfers within a period of four weeks from the date of receipt of representations. If the applicants do not represent, they shall be deemed to have accepted their order for transfer and may be dealt with accordingly. With these directions the bunch of D.As. stands disposed of. There shall be no order as to costs.

6. The original record of transfer which had been produced by the learned counsel for the respondents has been returned to learned counsel for the respondents at the time this case was considered by us today.
