nature mainly on similar grounds and, therefore, all these six cases are being decided through one order.

2. The applicants have impugned the transfer order mainly on the ground of being illegal, arbitrary, malafide, without jurisdiction and against the provisions made for transfer of Divisional Accounts Officer.

3. The respondents have contested the case and justified the impugned orders.

4. At the stage of hearing, learned counsel for the applicants not only made verbal submission, but also moved applications to dismiss the O.A. as withdrawn. The prayer not opposed. The O.As are dismissed accordingly. The interim order obviously stand vacated. No order as to costs.
