This O.A. has been filed as many as 75 applicants who have claimed the following reliefs:-

- "(i) to issue a mandamus to the respondents restraining them for compelling the applicants to discharge their duties of track machine operator/drivers and they should provide qualified and competent Track Machine Operators and drivers to run and operate the Track Machines.
- (ii) In the alternative to direct the respondents to grant them allowances, which are admissible to the running staff and to the applicants.
- (iii) to issue mandamus to the respondents to pay them extra salary/wages for the additional duty of driving the Track Machines as well as they are being made to work as operators and drivers both.

They have further sought a direction to give them all the consequential benefits."

2. All the applicants are either Junior Engineer Gr.I, Section Engineer or Sr. Section Engineer presently working under the Track Machine Organisation at Mughalsari. It is submitted by the applicants that medical category required for Track Machine Operators is A-3 and most of the applicants are having medical category of A-III while applicant No.21 and 46 only have medical category of B-I, whereas the medical category for drivers of Train is A-I. Therefore, when the Track Machine Operators are made to run the Track Machines from one point to the other points of long distances, It is not only a hazard for applicants but for the others as well because they do not have the medical category, which is required of an engine driver. It is submitted by the applicants that whenever there is an emergency due to an accident or otherwise

~~be 12~~ speed a very long distance but neither they know the signals
about the driving of engines nor have the medical category.
Therefore, it is not justifiable to make them drive the track
machine from the point of site to the starting point on
their own. For this purpose, it is submitted by them that
they should be given proper drivers so that Track Machines
are driven back safely to the starting point. In the alternative
it is submitted by them that since they are made to run the
Track Machines for quite some distance, they should be given
the running allowances as is being given to the train drivers.

3. It is submitted by the applicants that under the Indian Railways (Open Line) General Rules 1976 Driver has been defined in sub-rule 19 to mean the engine driver or any other competent railway servant for the time being in charge of driving a train. Train has further been defined in sub-rule 58 to mean an engine with or without vehicles attached or any self-propelled vehicle with or without a trailer, the which cannot be readily lifted off the track. Therefore, the Track Machines would be covered under the definition of self-propelled vehicle. It is further submitted by the applicant that they had even given representations to the authorities namely the Chief Personnel Officer, Eastern Railway, Falzeld Place, Calcutta, which are annexed with this O.A. on page 62, 63, 69 & 71 of the Paper Book. But since no reply has been given to them, therefore, they have no other option but to file the present O.A.

4. Respondents on the other have opposed this O.A. They have submitted that to modernise the Track which suits to safe passing of fast speed trains, the system from manually maintenance of track was switch over to machinised maintenance



somewhere in 1963 in the eastern Railway. Since then a new organisation namely Track Machine was added in the Eastern Railway. These track machines are highly sophisticated machines. Therefore, to operate and maintain them only qualified technical supervisors in different filed like electrical mechanical automobile, Civil etc. have been recruited. They are imparted technical training and transportation training for a period of 6 months and over a 6 months field training before posting them on machines for its operation and maintenance. Apart from it they are also being sent for refresher courses at Railway Institute IRTMC Allahabad and other private organisation for technical training from time to time. They were also sent to Zonal Training School Bhuli from 10.02.2000 to update their knowledge and safety.

5. They have further explained that basic function of track machine operator is to operate and maintain various track machines for the utilisation or maintenance of Tracks, and since only technically qualified persons can operate this machine therefore, they alone can handle the said track machines. They have further submitted that applicants are performing their duties within the prescribed duty and responsibility of track machine operators as given in the Indian Railway Track Machine Manual 2000 within the prescribed roster in 8 hours with weekly rest as per manual. If they work ^{are} ~~are~~ beyond roster hours, they have paid over time as per extant rules. Moreover, with each machine a camping coach has been provided where track machine operators can take rest after duty hours. They have further submitted that the matter was raised through recognised union regarding posting of a separate driver before the highest forum i.e. JCM on 10.06.1997 at Railway Board and discussed in presence of

AIRF, General Secretary and NFIR General Secretary along with Chairman, Railway Board as also other officials in which it was explained that it may not be possible to provide a separate driver only for driving. The Chargeman-cum-operators who are working in the operating machines are quite capable of driving the machine also which was agreed to by representative. Moreover the safety training of the assigned job is mandatory. They have further submitted that medical category of Track Machine Operators has been decided ~~as per B~~ ^{as per B} nature of job and as per Indian Railway Track Machine Manual Pg.126, which is A-3. Therefore, they are performing their duties, ^{for} which they are appointed and trained. They have, thus, submitted that there is no merit in the D.A. the same may therefore, be dismissed.

6. We have heard both the counsel and perused the pleadings as well.

7. At the very outset we would like to make it clear that sitting here in court we do not know at all the working about the Track Machine or Railway Engine or Trains etc. what are the requirements of a track machine whether those can be driven by separate drivers or not and whether it is possible for the Railways to provide separate drivers for running the track machine etc. is not known to us because that is not our field, the experts on the subject ~~can~~ alone ^{can} decide these matters. If applicants have any grievance which they feel can pose a safety hazard due to their low medical category required for the post of track machine where-as higher category is required for the engine drivers ^{they are facing} problems ~~which~~ have to be placed before the authorities.


8. Perusal of the representation on Pg.61 onwards shows

that in none of the representations, applicants have given a detailed grievance, the representations are rather stereotyped in nature without specifying the difficulties which are being ~~placed~~^{faced B} by the Track Machine Operators. Therefore, we think, it would be better if applicants are directed to give a self contained detailed representation to the authorities concerned, detailing therein the actual difficulties, which are faced by them for example with regard to their eye^{sight} or ignorance of the signals etc. while driving the track machine by putting them serial wise so that authorities may apply their mind to the grievances set out by the applicants and pass reasoned and detailed orders thereon under intimation to the applicant. Accordingly, applicants are given one months time to file detailed representation setting out ~~of~~ their grievances in seriatum within a period of one month from the date of receipt of a copy of this order. In case such a representation is given by the applicants, the competent authority shall apply his mind to each of the grievances raised by the applicants and ~~then~~ pass reasoned order thereon within a period of 4 months thereafter under intimation to the applicants.

9. With the above above directions, this O.A. is disposed off with no order as to costs.
