

This application has been filed for a direction to the respondents to decide the pending representation of the applicants and absorb all the applicants as regular labour in the office of the respondents.


2. Shri J.K.N. Mishra learned counsel for the applicants and Shri G.R. Gupta, learned counsel for the respondents have been heard.

3. I find from Annexure-3, that the representation is made by the applicants ~~without~~ without any facts on the basis of which their claim ~~should~~ <sup>could</sup> be examined by the respondents.

There are as many as 22 applicants and the entire representation consists of only 5 lines, while in the O.A. a claim has been made that persons junior to the applicants have been regularised. There is no mention of this fact in the representation.

4. In the circumstances, I permit the applicants to file individual representations giving full details of their service as also substantiation of the fact that their juniors have been considered and appointed. If such a representation is filed by the applicants within one month, the same shall be decided within 3 months from the date of receipt by Respondent No.3.

5. With the above observation, the O.A. is disposed of at the stage of admission itself, with no order as to costs.
