





Heard Sri S. Agarwal, learned counsel for the applicant, Sri A.K. Gaur, learned counsel for respondents and perused the pleadings.

2. The applicants in this bunch of three O.As. have been working as Commission Vendors either at Allahabad or at Kanpur or at Varanasi Railway Platforms. Concededly, in T.I. Madhwan Vs. Union of India & others 1988 Supp. SCC 437, the Hon'ble Supreme Court was pleased to direct that "all persons working as Commission bearers and vendors on various Railway platforms belonging to the Central Railway and the South Central Railways would be absorbed progressively as members of the permanent Railway Catering Service as per the terms of paragraph 3 of the Memorandum No.76-TG-III/639/II dated Dec. 13, 1976 issued by the Joint Director, Traffic-Commercial (G)-II, Railway Board, New Delhi as and when vacancies to the posts of bearers in the Railway Catering Services occur. The concerned Railway administrations were directed to first absorb all the bearers registered in accordance with the aforesaid memorandum and thereafter the vendors, 80 in number coupled with the direction that 'until all the bearers and vendors are accordingly absorbed', the Railway Administration would not recruit or appoint any person either as a bearer or vendor on permanent basis in Railway Catering Service from any other source.


3. The applicants herein who too had filed writ petitions before the Hon'ble Supreme Court and their writ petitions, it is stated by Sri S. Agarwal, were disposed of in terms of T.I. Madhwan (Supra). Accordingly, it is submitted by the counsel for applicants, the applicants were entitled to get the benefits of the direction given by the Hon'ble Supreme Court in T.I

Madhwan case. A circular, it being Annexure No.5, also

came to be issued by the General Manager, Northern Railway, Hqrs. Office, Baroda House, New Delhi addressed to DRMs Allahabad, Lucknow, Moradabad, New Delhi and Ferozpur in respect of absorption of the Commission Agents, and vendors in terms of judgment aforestated.

It appears that before the judgment of Hon'ble Supreme Court was given effect to, a company registered under the Companies Act namely Indian Railway Catering and Tourism Corporation Ltd. came to be formed by the Railways. The Railway Board vide its circular dated 24/25.1.2002, which is the subject matter of impugment in the QAs came to be issued stipulating therein that with immediate effect IRCTC will manage transfer of entire catering/vending services both mobile and statistic including Commission Vendors/bearers whether large or small on Indian Railways Zonal Railways, and further that 'Zonal Railways will assign all the existing catering/vending licenses 'as is where is' basis in favour of IRCTC! IRCTC was required to decide, in consultation with zonal Railways, the modalities of transfers of all these activities and execute necessary arrangements with the railways as envisaged in the guidelines contained in MOI signed between IR and IRCTC.

4. The circular aforestated provides that vending services should be started immediately and completed latest by 31st March 2002. The reliefs claimed herein is basically that circular aforestated in so far it includes the Commission Vendors/Bearers and direct their transfer of services in Tourism Corporation, New Delhi be quashed. The relief of mandamus restraining the respondents from terminating or transferring the services of the applicants has also been sought coupled with a direction to respondents to treat the applicants as group 'B' 'C' and 'D' employees discharging their duties and to absorb them in accordance with the judgment of Hon'ble Supreme Court in the case







of T.I Madhwan Vs. Union of India & others (Supra).

5. The Railway Board, it appears, vide its circular dated 06.01.1992 bearing No.91/TGIII/600/15 has decided that all catering and vending activities and services of Zonal Railways, which had not been taken over by IRCTC would be transferred to IRCTC subject to certain conditions stipulated in the circular. One such condition relating to Commission Vendors is that the Commission Vendors/ catering services would function under the control of IRCTS. It would thus, appear that the change of control would not render the Commission vendors/bearer jobless. In a similar matter Hon'ble Delhi Court in in CMWP No. 14038/03 and in CMWP No.2502/03 of Indian Vendors Association Vs. Union of India & others while disposing of the aforesaid applications has made it clear that no change would be brought in unless and until the commission vendors were absorbed by the Railways.

6. Having regard to the said order passed by the Hon'ble High Court and the direction given by the Apex Court as also the circular dated 04.02.2003 issued by the Railway, we dispose of this application with a direction to respondents that unless and until commission vendors are absorbed by the Railway in terms of judgment of T.I Madhwan case, the applicants should be allowed to work and discharge their duties as commission vendors on same terms and conditions on which they have been working and no private agency would be brought in.

7. The OAs are disposed of in terms of the above direction with no order as to costs.
