




ORDER



These applicants have come with a case that long back they were engaged as Casual Worker in the Railways in Group 'D' and were subsequently conferred the temporary status on completing a certain period of service and were thereafter also regularized on the post of Helper Khalasi Grade I. They say that under the Assured Career Progression Scheme, a railway servant who completes 12 years of regular service is entitled to first such upgradation and on completing 24 years to the second upgradation but in spite of representation having been given by the applicant to the authority concerned, same have not been considered and given. Copy of the representation has been annexed as annexure-1. They say that under the Railway Board's Circular dated 01.10.1999, the applicants are entitled to such up gradation under the said scheme.

2. We think it would be just and proper to dispose of this O.A. at admission stage itself with suitable direction to Divisional Railway Manager, North Central Railway, Allahabad to consider and dispose of the representation, copy of which is annexure-1, in accordance with rules/orders within a period to be fixed by this Tribunal.

3. So, this O.A. is finally disposed of with a direction to respondent no.2- Divisional Railway Manager, North Central Railway, Allahabad to consider and dispose of the representation dated 21.02.2006 (copy of which is annexure-1) of the applicants by passing a speaking order in accordance with the relevant rules/orders/circulars on the subject within a period of 3 months from the date a certified copy of this Order be produced before him.
