


2. Learned counsel for the applicant submitted at the very outset that the appellate order passed by the Appellate Authority is (Annexure A-1 to the OA) wholly non-speaking and Cryptic and in view of decisions rendered by Hon'ble Supreme Court in *AIR 1986 SC 1173 : Ram Chand Vs. U.O.I. and others*, 2006 (11) SCC 147 : *Director IOC Vs. Santosh Kumar*, JT 1994 (1) SC 597 : *National Fertilizer Vs. P.K. Khanna* and 2006 SCC (L&S) 840 : *N.M. Arya Vs. United Insurance Co*, the appellate order is not at all sustainable.

3. Accordingly Appellate order dated 3/6.02.2007 (Annexure A-1 to the OA) is hereby quashed and set aside and the matter is remitted back for reconsideration to the Appellate Authority, by passing reasoned and speaking order within a period of three months from the date of receipt of a copy of this order.
