Learned counsel appearing for parties admitted that in view of the subsequent development particularly passing of final order dated 04.06.2008 in O.A No. 1124/05 (B.D. Pandey and Ors. Vs. U.O.I & Ors.) alongwith connected O.As, the Railway administration is proceeding to comply with the directions contained in the said order. In view thereof, the applicants, in this CCP, does not want to press this CCP.

Keeping in view the statement made on behalf of the opposite parties that final order of Tribunal in O.A No. 1124/05 (referred to above) is being complied with, we ignore the contempt, if any, committed by the opposite parties by breaching the interim order passed on M.A No. 407/08 in O.A No. 1124/05.
