1. The applicant in OA/435/87 filed under Section 19 of the Administrative Tribunals Act, 1985 is an Inspector of Exhibitions in the Directorate of Advertising and Visual Publicity, Govt. of India, Ahmedabad.

2. The applicant in OA/463/87 is Field Exhibition Officer, Directorate of Advertising and Visual Publicity, Govt. of India, Ministry of Information and Broadcasting, Ahmedabad.

Mr.K.K.Shah, learned counsel appearing for the above two applicants, at the end of his submissions, urged that he does not press for any relief except the relief that Govt. of India, Directorate of Advertising and Visual Publicity, Ministry of Information and Broadcasting,

Order No.3/2/68-Est.II, dated 31st July, 1968 which reads as follows:-

"On the recommendation of the Departmental Promotion Committee, the Director of Advertising and Visual Publicity hereby appoints the following Exhibition Assistants officiating as Field Exhibition Officers on ad hoc basis, to the grade of Field Exhibition Officer on regular basis in a temporary capacity with immediate effect, until further orders:-

5. Shri H.N.Watal
