J U D G M E N T

K.P.ACHARYA, MEMBER (J)

In this application under section 19 of the

Administrative Tribunals Act, 1985, the applicant prays for a direction to the respondents to adjust/ appoint the applicant as Extra-departmental Delivery Agent cum Extradepartmental Mail Carrier, in Palasola or Madhupur Branch Office or any other nearby post Office.

2. Shortly stated, the case of the applicant is that one Babaji Charan Mallik who was serving as Extradepartmental Delivery Agent in Alavar Post Office within Jagatsinghpur Sub-Division was removed from service on the allegation that he had committed misappropriation of Government cash. Against this order of removal Babaji Charan Mallik had come up before this Bench and had prayed to quash the order of removal. It formed subject matter of O.A. 215 of 1987 which was disposed of by this Bench on 20.7.1988 setting aside the order of removal passed by the appropriate authority. In consequence thereof we directed reinstatement of the said Babaji Charan Mallik. Due to reinstatement of the said Babaji Charan Mallik the applicant Pradipta Kumar Swain is bound to vacate the Office of the E.D.D.A cum E.D.M.C. of Alavar Post Office. The applicant Pradipta Kumar Swain has come up before this Bench with a prayer mentioned above.

3. We have heard Mr. R.N. Naik, learned counsel for the applicant and learned Senior Standing Counsel (Central) at some length. We would say that the Postmaster General and the Superintendent of Post Offices, Cuttack should devote their

attention to this matter and try to adjust the applicant or appoint him to the post of Extradepartmental Delivery Agent said to be lying vacant in Palasola, Madhupur Branch Office or in any other Post Office as we were told that the applicant has served in Alavar Post Office for last four years without any blemish against him,

4. Thus, this application is accordingly disposed of leaving the parties to bear their own costs.
