ORDER

D.P.HIREMATH, Heard Shri Biswajit Mohanty, learned counsel for the
petitioners and learned counsel for the Respondents.

2. In view of the position that reclassification as
prayed for by the petitioners has been done with
effect from 4.1.1991, the first part of the prayer now
the petitioners have prayed for in their application, is
squarely met by the respondents. Learned counsel for the
petitioners however submits that the benefits that should
accrue from that date have not been given. We find from
copy of the order produced by learned counsel for the
respondents that reclassification has been done with
effect from 4.1.1991. Copy of the letter dt.22.6.1992 of
the Divisional Rly. Manager, S.E. Railway with copy thereof
has been sent to the ^{Divisional} ~~Genl.~~ Accounts Officer for necessary
action and that order has been made in concurrence with
him. The petitioners' counsel however is not in a
position to state whether the petitioners have received the
benefit in pursuance of this order. Giving liberty

to the petitioners to make representations if they have not yet received the benefits we dispose of this application.
