



In this application under Section 19 of
Administrative Tribunals Act, 1985, eighty-three applicants,
who have been permitted to jointly pursue this application,
have prayed for a direction to the respondents to appoint
the applicants as well as all other persons who had appeared
at the recruitment test held in the year 1992 in pursuance
of the notice dated 13.8.1990 in Group D category of posts

within a stipulated date after publishing the result of the recruitment test. By way of interim relief, the applicants had prayed for a direction to the respondents not to make any appointment in Group-D category of posts in South Eastern Railway, Khurda Road Division, during the pendency of the O.A. On the date of admission of this O.A. on 7.9.1994 by way of interim relief it was ordered that any appointment in Group-D category in Khurda Road Division as fresh faces would be subject to the outcome of this case.

2. Facts of this case, according to the applicants, are that the S.E.Railway authorities in a notice dated 13.8.1990 (Annexure-1) invited applications from children of Railway employees who have retired on superannuation or voluntarily after 1.1.1987 or will be retiring from service by 31.12.1993, for enrolment as fresh faces as substitutes for utilisation on day to day casualties. Certain other conditions were also mentioned in this notice. It is not necessary to refer to all those conditions except to note that educational requirement was Class VIII pass with preference being given for higher educational qualification or vocational training. Age of the candidate was required to be between 18 and 28 years, with five years relaxation for reserved community candidates. It was also mentioned in the notice that only one application

will be received from a family of Railway servant retired or retiring in the manner indicated earlier. It was also provided that in case of deserving candidates with special merits, not covered by the above norms, the competent authority reserves the right of applying its discretion in giving special consideration to those candidates. The applications were required to reach the office of Senior Divisional Personnel Officer, S.E.Railway, Khurda Road, on or before 15.9.1990. The applicants' case is that in response to the above notice, about 18000 applications were received for being appointed in Class III Group-C posts within the stipulated date. After preliminary scrutiny, the departmental authorities issued call letters to all the applicants and others indicating the date of interview and the roll number assigned to the candidates. One such call letter issued to applicant no.1 is at Annexure-2. He was called to an interview on 17.12.1991. The applicants further state that accordingly interview/test was conducted on different dates in the year 1991-92 and this was completed. All the applicants appeared in the interview/test in the year 1991 or January 1992 and according to them, have done fairly well. But the departmental authorities have not declared the results and in the meantime, have appointed several outsiders on extraneous considerations.

One such order given to an outsider Arjun Samal for engagement as a substitute Khalasi is at Annexure-3. The applicants further state that they have written several letters and submitted a number of representations and they have been assured that result of the test will be published at an early date, but no action has been taken. In view of this, the applicants have come up with the prayers referred to earlier.

3. Respondents in their counter have submitted that a proposal for engagement of fresh persons/outsideers as substitutes in Mechanical and Traffic Departments of S.E.Railway, Khurda Road Division, was initiated after obtaining the sanction of the General Manager, S.E.Railway. The base year was taken as 1.1.1987 and the General Manager approved the proposal in principle for engagement of 500 fresh persons/outsideers as substitutes in Group-D category in Mechanical and Traffic Departments of Khurda Road Division. On receipt of sanction order, a notification was issued on 13.8.1990 inviting applications from the wards of Railway employees who have retired on superannuation or voluntarily retire during the period between 1.1.1987 to 31.12.1993 for enrolment of such outsideers/fresh persons as substitutes for utilisation against day to day casualties.

The notice dated 13.8.1990 indicated the different terms and conditions and it was mentioned that the inviting of applications is for enrolment of names to prepare a list of substitutes for utilisation against day to day casualties. The respondents have submitted that in response to the notice about 3000 applications were received from the wards of Railway employees. A Screening Committee was constituted consisting of four Railway officers to conduct the screening test which was held on different dates in 1991-92. While such test was being continued, complaints were made regarding the test to the Vigilance Organisation of the Railways which seized all the relevant documents and therefore, the Screening Committee was forced to keep the test in abeyance till finalisation of the enquiry by the Vigilance Organisation. The respondents have stated that Divisional Railway Manager (respondent no.3) who is in charge of supervising screening test has not received any final report about the conclusion of the enquiry by the Vigilance Department nor have the documents seized by the Vigilance Department been returned to the Khurda Road Division. Because of this, the selection procedure could not be completed. The respondents have further stated that the notice was not for giving the selected persons regular appointment but only for enrolling them as substitutes to be

engaged against day to day casualties. As regards engagement of Arjun Samal, the respondents have submitted in paragraph 12 of the counter that Arjun Samal was empanelled as a substitute not in pursuance of the notice at Annexure-1 but in consequence of other factors which, however, have not been spelt out by the respondents. On the above grounds, the respondents have opposed the prayer of the applicants.

4. We have heard the learned lawyer for the applicants and the learned Senior Counsel, Shri B.Pal appearing on behalf of the respondents and have also perused the records.

5. in course of hearing, the learned lawyer for the applicants submitted that in the meantime the Vigilance Organisation of the Railways have concluded the enquiry and returned the original documents to the concerned authorities and the respondents should be asked to verify and report on this. In view of this, the learned Senior Counsel appearing on behalf of the respondents was asked to report on the above point along with information if before seizure of the documents, interview/test of all eligible candidates was completed or not and what are the findings of the Vigilance Organisation with regard to the interview/test. For giving this information, four weeks time was allowed. But in spite of passage of much longer time, the learned Senior Counsel

appearing on behalf of the respondents did not submit any information on this point.

6. In the above context, we have considered the submissions made by the learned counsels of both sides. The admitted position was that there were allegations with regard to the interview/test conducted by the Screening Committee and on receipt of such allegations, enquiry was taken up by the Vigilance Organisation of the Railways which seized all the records. Under these circumstances, no fault can be found with the respondents for not publishing the results of the test. The applicants have prayed that the respondents should be directed to publish the result of the test within a time limit to be fixed by the Tribunal. It would not be correct to give such direction because in case during the enquiry by the Vigilance Organisation large scale irregularities have been proved, then the authorities will be within their rights to cancel the entire test. Without knowing what the allegations are and what are the results of the enquiry, it would not be correct to issue a blanket direction of the type prayed for by the applicants. At the same time, it is to be noted that the Vigilance Department seized the records sometime in January 1992 and started their enquiry. More than five years have passed in the meantime. It is, therefore, necessary that
