Heard Mr.S.N.Mishra, learned counsel for the applicant and Mr.J.K.Nayak, learned ACGSC for the respondents on the question of admission. Applicant is an officer of the Survey of India. His grievance is that although he has been promoted in the year 2005, the respondent-authorities while issuing order dated 5.4.2016 has shown him to have been promoted in the year 2014 and therefore, he is going to lose his seniority and consequential promotion to higher grade.

2. It is found that this order has been passed on 5.4.2016 and soon thereafter, applicant has rushed to the Tribunal. He has not specifically ventilated his grievance before the concerned authorities. Mr.J.K.Nayak submitted that the orders have been passed on the basis of the decisions of CAT, Bangalore Bench and of other Benches of the Tribunal. On being pointed out as to how applicant without availing of the departmental remedies has approached the Tribunal, Mr.Mishra sought permission of this Tribunal to prefer a representation before res.no.2 specifically urging his grievance within two weeks hence and if any such representation is filed, respondent no.2 is directed to consider and dispose of the same in the light of extant rules and instructions and communicate the decision thereon through a reasoned and speaking order within a period of ninety days from the date of receipt of representation. However, applicant is at liberty to enclose copy of this order along with the representation to be preferred by him.

3. With the above observation and direction, this O.A. is disposed of at the stage of admission itself. No costs.

4. On the prayer made by the learned counsel copy of this order along with paper book be sent to res.no.2 at the cost of the applicant for which Mr.Mishra undertakes to file the postal requisites by 23.5.2016. Free copy of this order be made over to learned counsel for both the sides.
