ORDER(Oral)

SHRI A.K.PATNAIK, MEMBER(J):

In this O.A. NALCO Officers' Association having a common cause of action have moved this Tribunal. They have filed M.A.No.1146/12 seeking permission to jointly prosecute this O.A. The prayer is allowed. M.A.1146/12 is thus disposed of.

2. Heard Shri S.K.Nayak on behalf of Shri S.Palit, learned counsel for the applicant. Defects pointed out by the Registry have not been removed. However, we find that the Applicants' Association have made several representations vide Annexure-A/5 series, the last representation being dated 24.5.2012 ventilating their grievances to the Chairman-cum-Managing Director (Respondent No.1) According to Shri Nayak, Applicants-Association is yet to receive any response in this regard.

3. Therefore, without entering into the details of the defects pointed out by the Registry, we feel it proper to dispose of this O.A. by directing Chairman-cum-managing Director, NALCO(Res.No.1) to

consider and dispose of representation dated 24.5.2012, if not yet disposed of, through a reasoned and speaking order under intimation to the Applicants-Association, within a period of two months from the date of receipt of this order.

4. With the above observation and direction, this O.A. is disposed of at the admission stage itself. No costs.
