

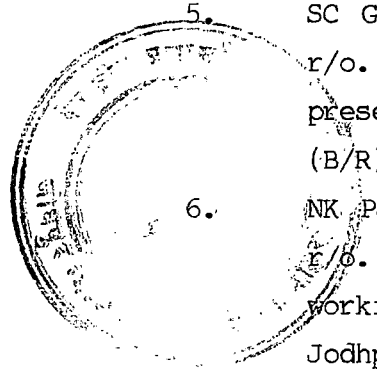



Applicants, abovenamed, have filed this application under Section 19 of the Administrative Tribunals Act, 1985, mainly praying for a declaration that they are entitled to be placed in the same pay scale as that of the direct recruits working as Assistant Garrison Engineers in Group 'A' services.


2. We have heard the learned counsel for the applicants.

3. The grievance of the applicants is that treating the direct recruits as Assistant Garrison Engineer in Group 'A' services and the promotees as Assistant Garrison Engineer in Group 'B' services is arbitrary and violative of Articles 14 and 16 of the Constitution.

4. It must be mentioned here that the question of equivalence of post and equivalence of pay is a matter which lies within the domain of the Expert Committee, like Pay Commission. Since the applicants had already made a representation to the concerned authority vide Annexure A/8 dated 9.11.98, we dispose of the present application with the direction to the respondent No. 2 to take a decision on the representation through a detailed speaking order on merits within a period of six months from the date of receipt of a copy of this order.

5. Let a copy of the application and the annexures thereto be sent to the respondent No. 2 alongwith a copy of this order. The O.A. stands disposed of accordingly.
