### **ORDER**

#### **Mr. Kuldip Singh, Vice Chairman.**

Heard the learned counsel for the parties.

2. O.A. No. 225/2006 has been filed jointly by 28 applicants who are working in the Central Ground Water Board, Jodhpur in various capacities. It is stated that the applicants belong to Group C and Group D category. They submitted medical reimbursement claim relating to the years 1996-1998, but the same were not reimbursed to them. The cases of the applicants were put up before the competent authority i.e. the Chairman, Central Ground Water Board, Faridabad. But the Director (Admn) vide his letter dated 30.08.2004, conveyed

that the competent authority<sup>-4-</sup> has considered their case sympathetically but regret to say that the same is not approved by the said authority.

3. The respondents vide their reply submitted that there were complaints that medical facilities are being misused by the claimants working under respondent No. 3 at Jodhpur and it was found that the claims were on higher side. It is also submitted that the matter of claiming fake medical bills was initially inquired into by the Director (Admn) Vigilance officer of the Department and thereafter the matter was referred to the CBI for conducting investigation. After inquiry the CBI returned the medical bills without any recommendation for making payment. Hence the respondents have rightly not reimbursed the claims.




4. Be that as it may, since it is an admitted case of both the parties that the medical bills submitted by the applicants are still pending and no final decision has been taken by the respondent department as stated by the learned counsel for the applicants I find that the respondents are under obligation to decide the claim of the applicants in accordance with the prevalent rules for the purpose. The learned counsel for the respondents submitted that he is not sure whether any decision has been taken already and communicated. In view of these circumstances, the respondents are directed to scrutinize the

pending medical reimbursement claims in accordance with the CS (MA) Rules, 1944 and convey the decision taken, if no decision has been already communicated to the applicants within a period of two months from today. O.A. is disposed of in the above terms. No costs.
