ORDER

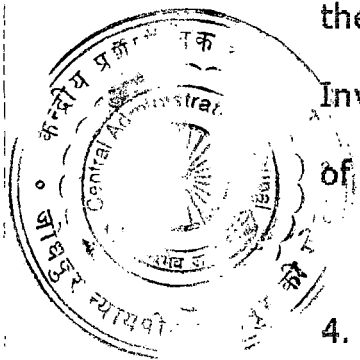
Heard the learned counsel for the parties.

2. This O.A. has been filed jointly by 41 applicants, who are working in Central Ground Water Board in different capacities. It is contended that during the period 1996-1998, these employees had submitted various medical bills for reimbursement but the respondents declined to clear the same. The matter of passing the old medical reimbursement bills was put up before the competent authority i.e. the Chairman, Central Ground Water Board, Faridabad (Respondent No.3). On this, the Director (Admn.) Central Ground Water Board, Faridabad intimated vide its letter dated 30th August,

2004 at Annex. A/1 that the competent authority considered the applicants' case sympathetically but did not approve the same. Hence, the pending medical reimbursement bills have not been processed.

3. The respondents in their reply submitted that there were complaints on large scale that medical facilities provided to the employees under the respondents No. 3 at Jodhpur are being mis-used and even it was found that the claims were on higher side. The matter of claiming fake medical bills was initially inquired by the Director (Amdn) and a Vigilance Officer of the Department and thereafter even a complaint was made to the Central Bureau of Investigation to investigate the issue and keeping in view this state of affair, Annex. A/1 was passed.




4. The respondents have also taken an objection that the letter which the applicant has filed as Annex. A/1, is in fact an internal correspondence and had not been addressed to any of the applicants', so even this Original Application cannot be filed as not maintainable.

5. Be that as it may, since it is an admitted case of both the parties that the medical bills submitted by the applicants' are still pending and no final decision has been taken by the respondent-department, as stated by the learned counsel for the applicant, we find that respondents are under an obligation to decide the claim of the applicants in accordance with the prevalent rules for the purpose. The learned counsel for the respondents submitted that he is not sure that decision has already been taken or communicated.

Ka

In these circumstances, we direct the respondents to process and scrutinize the pending medical reimbursement bills of each applicant in accordance with the Medical Reimbursement Rules and convey them the decision taken thereupon, if no decision has already been communicated, within a period of two months from today.

6. The O.A. stands disposed of accordingly with no orders as to cost.
