

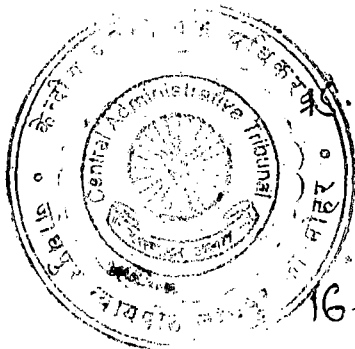

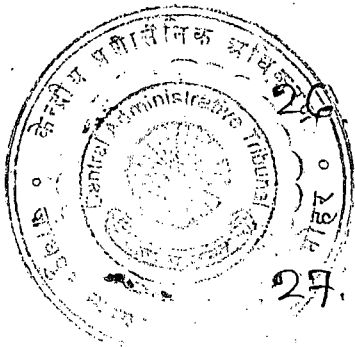

ORDER (ORAL)

This matter was heard earlier by a coordinate Bench but it was not declared as part-heard, therefore, it came before us. The learned counsel for the respondents would submit that the matter relates to a seniority list which was issued much much before and which had been superseded after hearing the objections from many others. On 12.8.2004 the respondents have issued a seniority list subsequent to the earlier one filed by the applicant as Annex.A-1 and challenging it and thus, this seniority list (filed as Annex. R/2 along with the reply) was issued prior to the filing of this Original Application i.e. on 4.1.2006. Therefore, the cause under which the applicant would agitate was never in existence, thus, the learned counsel for respondents submits that the O.A. would fail on the issue.


2- At this juncture, the applicant appears to have filed an amendment application. Going by the various judgements of the Apex Court and the provisions of Civil Procedure Code, under



Order VI Rule 17, it is apparent that a cause which has been extinguished cannot be rejuvenated through an amendment as it will prejudice the respondents who are already in the array but also the others, who may be adversely affected, therefore, the amendment sought cannot be allowed. Besides, even before the filing of the OA, the relief is infructuous. Since the cause in the instant application has already been extinguished, the amendment application at this stage is denied and the OA is dismissed. But, we allow a liberty to the applicant to agitate the matter afresh if he is so advised.

3- The O.A. is dismissed as above. Since the OA itself has been dismissed giving liberty to the applicant, the MA Nos. 23/2006 and M.A. 140/2010, do not survive.
