ORDER (ORAL)

PER JUSTICE K.C. JOSHI :

Heard the learned counsel for the parties.

2. The learned counsel for the official respondents Mr. Manoj Bhandari submits that the present Application is squarely covered by the judgment of the Hon'ble Supreme Court delivered in ***Union of India Vs. Pushpa Rani and Others*** and a Batch, reported in 2008 (9) SCC 242. The Counsel for the applicant also agrees to the legal proposition as pronounced by the Hon'ble Supreme Court in the case of ***Pushpa Rani & Ors.*** Thus, in view of this pronouncement by the Hon'ble Supreme Court, the present Original Application is dismissed.

3. The Misc. Application for condonation of delay is also dismissed as not survive in view of the aforesaid discussion.

4. There is no order as to costs.
