ORDER

Heard the learned counsels on both sides. Learned counsels on both sides submitted that a similar matter O.A. 243 of 2006 was decided by this Bench of the Tribunal and allowed the same in favour of the applicant therein vide order dated 12.8.2010. Since these O.As are also of identical nature, the applicants herein, are also entitled to be benefitted from the said order.

2. It is stated that the said order has been challenged in D.B.(Civil) Writ Petition No.10603 of 2010 before the Hon'ble Rajasthan High Court at Jodhpur, and, therefore, we direct that based on the resolution/decision in the said Writ Petition the applicants herein be granted the same quantum of benefit as is available to the applicant(s) in OA 243/2006.

3. In view of the above, the present O.A Nos. 302/2010, 29/2011, 30/2011, 31/2011, 32/2011, 33/2011, 34/2011, 35/2011, 40/2011, 41/2011 & 107/2011 stands disposed of along with the applications for condonation of delay.
