


## Respondents

## ORDER

### BY THE COURT :

The above cases mentioned in the Cause Title, are similar in nature and arise from identical cause of action. These cases are, therefore, being disposed of by means of a common order.

2. The applicants were engaged as daily wage casual workers in capacity of computer operator / Data Entry Operator / Peon / Sweeper / Driver / Chowkidar and Cook on various dates mentioned against their name in the Original Application. The grievance of the applicants arise from the communication dated 19.10.2012 (Annex.A-1) enclosing the Minutes of the meeting on various issues of litigation of data entry operators / casual workers held in the chamber of Director of Income Tax (I in CI) Rajasthan Jaipur on 17.10.2012. It transpires from a perusal of the Minutes that earlier this Bench of the Tribunal had passed an order on 14.8.2012 in OA No. 121/2010 whereby the order of the respondent-department for reducing wages from Rs.292/- to Rs. 164/- has been quashed. It further appears from the proceedings of the meeting that the payment of Rs. 292/- is being received by such incumbents consequent to the above order. However, in O.A. No. 121/2010 vide its order dated 22.2.2012, this Bench had



Stayed the process of issuance of notice calling for tenders for service providers. The respondent - department has filed a Writ Petition before the Hon'ble High Court of Jodhpur Bench vide C.W. No. 1924/2011 wherein, the Hon'ble High Court has been pleased to hold vide its order dated 14.09.2012 as under :-

*"... It is submitted that as assurance was given on behalf of the respondents that the work will be taken from the employees concerned and they will have to receive the payment from the Contractor and not from the Income-tax Department. Having considered all the facts of the case, we are inclined to modify the order dated 22.07.2011 by directing the respondents to employ respondents No. 2 to 10 through contractor."*

3. In view of the aforesaid order, the Department has do away with the services of the casual workers and replace them by employees outsourced through service provider and have constituted a committee for piloting this transition.

4. The above matter had been challenged in this Tribunal and had been disposed of by its order dated 19.10.2012 vide OA No.

17/2012 ***Mahendra Singh and Ors. Vs. UOI & Ors.*** and a batch.

Some other similarly placed applicants had approached this Tribunal vide OA No. 470 and 471 of 2012 expressing similar apprehension. These cases were disposed of with the directions :

"However, in view of the apprehension expressed by the applicants, both these OAs are remanded back to the respondent No. 2 for consideration in the light of the aforementioned order of the Tribunal delivered in ***Mahendra Singh and Ors. Vs. UOI & Ors.*** (supra) on 29<sup>th</sup> October, 2012, by means of a speaking order. It is

further directed that respondents will not terminate the services of the applicants till such decision is taken." The same ratio shall also apply to the instant set of cases.

5. All the three OAs are being disposed of at the stage of admission itself with these directions
