2. It appears that the Hon'ble High Court in similar and connected matters in D.B. Civil Writ Petition No. 5530/2013 vide order dated 19.03.2015 held that the employees who approached the court will only come within the ambit of the department employees. All others are external employees and between them and the department, there might be a contractor and in that case, they are not eligible for bonus. All other employees who come within these orders of the Hon'ble High Court and in-situ as on 19.03.2015 will be entitled to payment of bonus. OA and MA No.388/2014 are disposed of accordingly.
