### COMMON ORDER

Per Sh. U. Sarathchandran

These cases have been heard together, with the consent of the counsel appearing for both sides in each case, since the facts and issues are similar in all these cases. In view of the similar nature of grievance, facts and circumstances of these cases we felt that a common order can be passed, in order to avoid inconsistency. For the sake of convenience the documents annexed to OA No.290/00001/2016 and the pleadings of both sides therein are referred to in this common order which would be germane to the parties in the other OAs *mutatis mutaindis*.



2. This batch of OAs stems from the order of termination of the applicants from the post of Postal Assistant/Sorting Assistant in which they have been working after getting selected as Postal Assistant/Sorting Assistant in a nation-wide recruitment process undertaken by the Department of Posts in the 22 Postal Circles of the country. The post of Postal Assistant (for short 'PA') was for the vacancies of the year 2013-14. The recruitment process was set in motion by issuance of Annexure-A/2 notification. Conducting of the written examination/aptitude test viz: (paper 1) and computer/ typing test (paper 2) were entrusted to an outside agency by name M/s CMC Limited, Noida UP which appears to be having a registered office at "CMC" House, C-18, Bandra Kurla Complex (BKC) Bandra (East), Mumbai 400051. Applicants in these OAs who were appointed after selection were posted as Postal Assistant/Sorting Assistant (for short, SA) at a different stations. They were sent for training at the Postal Training Centre and on successful completion of the training they have been working as Postal Assistant. Out of the blue they were served with Annexure-A/1 order of termination of service, which reads :

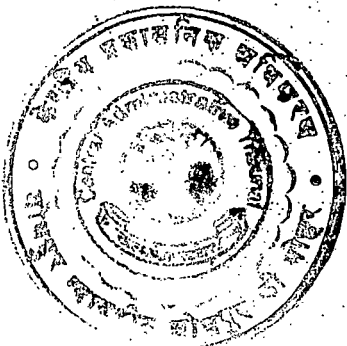
In pursuance of the proviso to sub-rule (1) of rule 5 of the Central Civil Services (Temporary Service) Rules, 1965 I hereby terminate forthwith the services of Shri Shyam Singh, PA Nana (name) and directed that he shall be entitled to claim a sum equivalent to the amount of his pay and allowances for a period of one month (in lieu of the period of notice) calculated at the same rate at which he was drawing them immediately before the date on which this order is served on or, as the case may be, tendered to him.

3. A cheque for one month's salary was also served on the applicants in lieu of one month's notice. According to the applicants Annexure-A/1 termination order issued to them was without any prior notice or opportunity of being heard and no inquiry of any kind was conducted. It is further alleged that Annexure-A/1 order is a cryptic order passed by the respondents to synchronise with the closing of the Courts and Tribunals for winter vacation. Applicants allege that they have not committed any illegality, misrepresentation and malpractices either in the written examination, during the selection process or during training and there is no case from any corner that their services have been unsatisfactory. Therefore they pray for quashing and setting aside the Annexure-A/1 order and seek the consequential benefits which would flow out of this Tribunal's order.

4. Respondents filed a reply statement through the Additional Central Government Standing Counsel Shri K.S. Yadav, with a prayer for treating the reply statement filed in OA No.290/00001/2016 as the reply statement in all the other OAs dealt with in this common order. According to the respondents the applicants have been terminated from the posts of PA/SA from various offices by taking recourse under Rule 5 of Central Civil Services (Temporary Service) Rules, 1965 (for short, 'TS' rules). Respondents further state that after declaration of the result of the candidates from the Rajasthan Circle on 08.11.2014 certain complaints of malpractices in recruitment process were received in the Postal Directorate on 8/9-04-2015 alleging the practice of unfair means and irregularities in the Gujarat Circle. The Vigilance Team of

the Postal Directorate enquired into the allegations and prima facie it was found that there were sufficient reasons to suspect serious malpractices on the part of candidates with and without the connivance of the aforesaid outsourcing agency. Based on the prima facie suspicion, the competent authority ordered to keep in abeyance all further appointments/ training in all 22 Postal Circles of the country where the examinations were held through aforesaid outsourcing agency. In the meantime most of the selected candidates had already been given appointment in the Rajasthan Circle. Thereafter a detailed investigation on the conduct of examination in other Postal Circles was taken up. After preliminary inquiry, no malpractices were found in 11 Postal Circles whereas in five Postal Circles viz. Rajasthan, Gujarat, Haryana, Uttarakhand and Chattisgarh certain irregularities at mass level were noticed on the part of many candidates, officials of outsourcing agency indicating leakage of question paper/ answer key of the papers. The irregularities noticed included cases of impersonation in one of the Postal Circle. The other Postal Circles were alerted to carry out a thorough checking of personal details, comparison of signatures, photographs etc. and other relevant record generated at the various stages of the examinations before granting appointments. Due to the irregularities noticed a decision of re-examination was also taken in the Postal Circles of Delhi, Himachal Pradesh and Madhya Pradesh where the fair conduct of the examination was under cloud of suspicion. The investigation revealed serious irregularities in the Postal Circle of Rajasthan also. According to the respondents some of the irregularities found in the recruitment process in the State of Rajasthan are :

- a. It is observed that majority of the selected candidates are locals, while only 44 out of 427 candidates are outsiders. Majority of the outsiders belong to Haryana (36 out of 44) and Bihar (4). Further,



candidates which have been selected from Haryana State are found to be from one of the area of suspected geographical belt namely Mahendragarh (21 are from Mahendragarh, out of which 19 candidates belong to a few villages in Narnaul Tehsil along i.e. 5 candidates belong to village Saidpur, 4 candidates from village Goad & 3 candidates from Gulawala) and Rewari (5). Surprisingly, 16 candidates out of 26 share a few common email ids. 10 candidates out of this group of 26 have less than 60% in their Senior Secondary Examination.

iii. Other cases of Same Address/ Close Locality: Besides the cases of Mahendragarh District as mentioned above, other local candidates pertaining to Alwar District have also been noticed to have succeeded in groups. It is observed that 27 candidates are such which belong to Alwar District in which 9 candidates are from Kotkasim, 6 are from Kishangarh Bas and 3 each from Bhror and Kala Kuan.

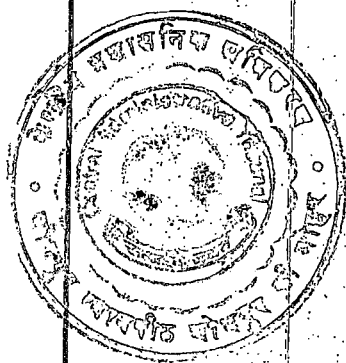
a. It is also observed that a few candidates belonging to same area have used same email id at the time of registration. These email ids are pnaveen2791@gmail.com, 2nd.11.113@gmail.com, radhe9772377171@gmail.com and lion110001@gmail.com having being used by 2 candidates each and in the same area/locality.

b. Further, a groups of 5 candidates belonging to exactly the same address i.e. " Room No.5, Arawali Hostel, University of Rajasthan, Jaipur succeeded in the recruitment examination and it may further be seen that they have scored marks in a close range with similar patterns in Para A,B,C and D of Paper I. Out of these 5 candidates, 3 have used common email ID and two of them siblings.

iv. Siblings/relatives: A very surprising fact emerged during the investigation is that in Rajasthan a large number of Siblings (37 candidates) succeeded in the recruitment examination. As many as 18 pairs of suspected siblings/ relatives on the basis of same father names and addresses have been detected. Among these 18 pairs, 5 pairs appear to be definite pairs of siblings as per their common address; they have all succeeded in the recruitment exam. Out of these five pairs, it may be seen that two daughters and one son of Shri. Nanga Ram got through the recruitment examination and got almost similar pattern of marks. It seems that in order to avoid divulging fact of being sibling/relative, different addresses have been mentioned in some cases while father's name of 13 pairs (excluding 5 definite pairs of siblings) are same which may not be a mere coincidence. Discrete physical verification of residential addresses of these candidates with reference to proof of residence obtained from these candidates, physical verification of addresses appears necessary.

v. Same E-mail ids: 26 such cases were found suspected where same e-mail ids have been used more than once as mentioned below. The detailed analysis is placed as Annexure-RAJ-B. There are some bigger groups using same email IDs like 7 candidates have used e-mail ID as itrsnnl@gmail.com & surprisingly they are from the suspected belt of "Narnaul". Among these 7 candidates 4 are having same mobile numbers as 946849802. Similarly there is another such big group of 7 candidates using same e-mail id sarvanjangir@gmail.com (out of which 5 are from Narnaul Tehsil, District Mahindergarh) and among these 4 have given same mobile No. as 9992920462. In addition to this one email id nechacafe@gmail.com was also found to be used by 4 candidates. Further it was also found during the analysis of Rajasthan and Uttarkhand Circle that two candidates each from both the Circle have used same e-mail id as sunilbharti79@gmail.com.

vi. Same pattern of marks: 93 candidates have been found suspected having same marks pattern of marks in part A, Part B, Part C & Part D of Paper I. Detailed analysis is placed vide Annexure-RAJ-C. The average percentage of marks scored in class 12th of these candidates is 64.19% & the average percentage of marks obtained by these candidates in Paper I is 87%. 2 have email id



dinesh,ramavat2000@gamil.com and other 2 have email id shyamsunder061995@gamilcom. Besides these 2 above Shri Ramesh Kumar S/o Shera Ram has also given email id ramawat\_j@rediffmail.com which is similar to the above case. However, their OMR sheets needs to be further scrutinized by the Circle team before arriving at any conclusion so as to say whether there is a pattern marking of wrong answers too.

vii. Answer Key Pattern: the original answer key was designed by CMC Ltd. For 4 series viz. Series A,B,C&D. However, on deep analysis of all the four keys it is observed that the key is so designed that from key of series A, keys of all other series can be prepared by just changing the first question number of the key. For example, to obtain the answer key on next series one has to jump to predefined count for example if one wants to get the answer key of B series if he has the answer key of series A then one need to start using the key from 7th question and so on.

ix. It has been observed that there exists major difference in marks scored by the candidates in recruitment examination as compared with their 12th class scores. The same is places at Annexure-RAJ-D. There are 92 candidates who have secured excessively high marks in recruitment examination as compared with their 12th class marks i.e. difference is more than or equal to 30%.

x. 113 candidates are such that they have scored less than or equal to 55% in class 12th."

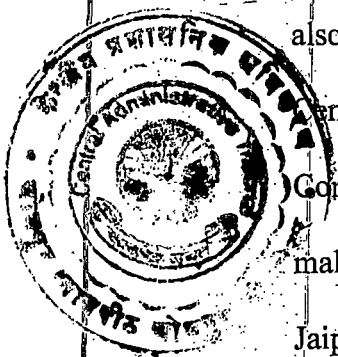
5. According to the respondents the entire recruitment process in the State of Rajasthan was compromised because of the use of unfair means and leakage of question paper/answer key. According to the respondents it is difficult to segregate the culprits and other candidates and therefore whole exam is liable to quashed and therefore as per decision of the competent authority Annexure-A/2 the impugned Annexure-A/1 order was passed terminating the service of the applicants.

6. As indicated above, cancellation of appointment in pursuance of Annexure-A/2 notification was ordered in other circles also. The persons in other postal circles who were affected by the impugned termination order have approached the different co-ordinate Benches of this Tribunal having territorial jurisdiction. Therefore we have the advantage of perusing the final orders passed by the co-ordinate Benches of this Tribunal at Ahmedabad, Jabalpur, Principal Bench, and also by the co-ordinate Bench at Jaipur, in the chronological order.

7. We have carefully perused the final order dated 18.03.2016 (Common Order) of the Ahmedabad Bench in OA No.478 of 2015 and the connected case. In the final order dated 08.04.2016, the Principal Bench of this Tribunal in OA No.4719/2015 and connected cases concurring with the final order passed by the Ahmedabad Bench directed the respondents to grant the same benefits to the applicants before the Principal Bench. The coordinate Bench at Jabalpur in its common order dated 29.04.2016 also followed the suit and adopted the directions in final orders of the Ahmedabad Bench and ordered to give the same benefits to the applicants before the Jabalpur Bench.

8. Of late, we have had the benefit of seeing the common final order dated 25.05.2016 of the co-ordinate Bench at Jaipur in OA No.291/00008/2016 and connected cases.

9. The Jaipur Bench in its common order dated 25.05.2016 has generally followed the directions contained in the final orders dated 18.03.2016 passed by the Ahmedabad Bench in OA No.478/2015 and the connected case but has also added a mandate to the premier investigating agency of the country-the Central Bureau of Investigation (CBI) and to the Central Vigilance Commission (CVC) to undertake an inquiry into the allegations of aforesaid malpractices. Making a detour from the view of the Ahmedabad Bench, the Jaipur Bench observed that the vigilance inquiry at the instance of Postal Directorate reveals that they have done a 'good job'. While concurring with the directions issued by the Ahmedabad Bench in its final common order dated 18.03.2016 in OA No.478/2015 and the connected case, the Jaipur Bench issued the following directions:



"15. After having heard the counsels for both the sides and examining the matter in a great detail, we hereby issue the following directions:

(i) The respondents will refer the matter to the CVC and CBI immediately and forthwith with all relevant documents/ record and position of the matter, so that they can immediately commence the preliminary enquiry. There will be a time of three months from today for completion of preliminary enquiry so that the applicants are innocent of the charges leveled against them and in that case at the end of three months period as granted, the applicants will be reinstated back in service.

16. At this stage, learned counsel for the respondents submits that at least four months' time may be granted for completion of the enquiry by the CVC and CBI. It is allowed.

17. It appears through the vigilance report and after hearing the counsels for the parties that there might be involvement of senior officers of the department also, it is, therefore, necessary to weed out all of these persons and take appropriate action against them, which shall also be taken within the aforesaid period.

18. There will be a mandate to the CVC and CBI to treat this matter as very urgent as question of livelihood of so many persons is there, and integrity to be maintained in Government servant in a question, therefore, urgent action will be required to be taken by the CVC and CBI in the matter within a period of four months' time as sought by the respondents. It is to be noted that following orders of other Benches sufficient time is already granted.

19. Besides, there may not be any difficulty in this matter as after having gone through the vigilance report it appears that there might be involvement of senior officers of the department itself and most the issues are taken care of.

20. It is made clear that if name of anyone of the applicants is found in such a racket then notice(s) shall be issued to them within 15 days after completion of four months' time already granted to the CVC and CBI for completion of enquiry and appropriate action may be taken against them so that justice may be done. For those applicants who are found innocent in the matter, their rights of employment and consequences thereof shall follow within a period of four months from today as aforesaid.

21. With these observations and directions, all the Original Applications are disposed of with no order as to costs."



10. During the hearing of the OAs on hand, learned counsel appearing on both sides agreed that they have no objection for passing the same directions in the present case also. Hence we proceed to issue the following order:

11. In the result, while respectfully concurring with the directions issued by the Jaipur Bench as extracted above, we direct the respondents that the benefits in the above aforesaid orders be conferred to the applicants in the OAs dealt

with in this common order also. Ordered accordingly. We further direct the respondents to forward copies of this common order to the Director of Central Bureau of Investigation and also to the Chief Vigilance Commissioner, CVC, Government of India for the purpose of taking necessary action in the light of the directions contained in the afore-quoted order of the co-ordinate bench of this Tribunal at Jaipur.

The OAs are disposed of as above. As the OAs have been finally disposed of, the interim order already granted will cease to be in operation.
