
In the instant case applicants alleged that their Seniority was not properly assigned by the respondents and accordingly they made representations on 8.1.2000 (Annexure 'Y' to the MA bearing No.206 of 2000) and that representation has not been disposed of by the respondents as yet. We find that O.A. bearing No.769/97 was admitted with direction upon the respondents to file reply; but respondents did not file any reply till today. We also find that applicants made another representation for correction of the Seniority Position by letter dated 23.7.1996 (Annexure 'A' to the O.A.) and that

represent<sup>-ation</sup> had not also been disposed of by the respondents. Under the aforesaid circumstances we are of the view that both the O.A. and M.A. can be disposed of with a direction upon the respondents to dispose of the representation dated 8.1.2000 (Annexure 'Y' to the M.A.) and representation dated 23.7.1996 (Annexure 'A' to the O.A.). Accordingly, O.A. bearing No.769 of 97 is also taken up on today's list alongwith M.A. bearing No.206 of 2000.

2. In view of the aforesaid circumstances we direct the respondents to dispose of the representation dated 8.1.2000 (Annexure 'Y' to the M.A.) and representation dated 23.7.1996 (Annexure 'A' to the O.A.) with reasoned and speaking order treating this application as a part of the representation within 2 (two) months from the date of communication of this order. It be mentioned that Seniority List should not be finalised till the disposal of the representations within the period stated above. Liberty is given to the applicants to approach this Tribunal if they are aggrieved by the decision to be taken by the respondents. With this observation both the M.A. and O.A. are disposed of.
