O R D E R

HON'BLE MR. A.M. SIVADAS, JUDICIAL MEMBER

Since the issue involved is identical in all these OAs, all these OAs were heard together and are disposed of by this common order.

2. Applicants in O.A.426/99 seek the following reliefs:

"(i) To declare that the provisions in column No.12 of Schedules to Junior Telecom Officers Recruitment Rule 1996, to the extent it excludes Senior Telecom Office Assistants with prescribed qualification for direct recruitment as Junior Telecom Officers, from the feeder category of Junior Telecom Officers for appointment by transfer/promotion is ultravires Article 14 & 16 of the Constitution of India;

(ii) To direct the respondents to consider the applicants for appointment by transfer/promotion as Junior Telecom Officers against the whole 50% vacancies of Junior Telecom Officers, along with others eligible without discrimination.

(iii) Grant such other reliefs as may be prayed for and the Court may deem fit to grant, and

(iv) Grant the cost of this Original Application."

3. Applicant in O.A. 427/99 seeks the following reliefs:

"(i) To quash Annexure A1,

(ii) To declare that the provisions in column No.12 of the schedule to Junior Telecom Officers Recruitment Rules, 1996, to the extent it excludes Technical Supervisors, from the feeder category of Junior Telecom Officers for appointment by transfer/promotion is ultravires Article 14 & 16 of the Constitution of India;

(iii) To direct the respondents to consider the applicant for appointment by transfer/promotion as Junior Telecom Officers against the whole 50% vacancies of Junior Telecom Officers, along with others eligible without discrimination.

(iv) Grant such other reliefs as may be prayed for and the Court may deem fit to grant; and

(v) Grant the cost of this Original Application.

(d) Declare that the applicants are eligible to be considered for promotion as Junior Telecom Officers on par with Telecom Technical Assistants against 35% quota vacancies,

(e) Direct the respondents to consider the applicants for promotion against 35% quota vacancies in the cadre of Junior Telecom Officers reflected in Annexure A5 and to grant the consequential benefits thereof,

(f) Direct the respondents to consider the applicants for promotion as Junior Telecom Officers on par with Phone Inspectors/Transmission Assistants/Auto Exchange Assistants and Wireless Operators having the requisite qualification meant for direct recruitment and to grant the consequential benefits thereof; and

(g) Pass such other orders or directions as deemed just, fit and necessary in the facts and circumstances of the case.

5. Applicants in O.A.479/99 seek the following reliefs:

(a) Declare that the denial of consideration for promotion to the applicants to the cadre of Junior Telecom Officers is highly arbitrary, discriminatory and unconstitutional,

(b) Call for the records leading to the issue of Annexure A3 and A4 and quash the same to the extent they deny consideration to the applicants for promotion as Junior Telecom Officers on par with Telecom Technical Assistants,

(c) Call for the records leading to the issue of Annexure A5 and quash the same to the extent it denies consideration to the Senior Telecom Operating Assistants for promotion to the post of Junior Telecom Officers against 35% quota,

(d) Declare that the applicants are eligible to be considered for promotion as Junior Telecom Officers on par with Telecom Technical Assistants against 35% quota vacancies,

(e) Direct the respondents to consider the applicants for promotion against 35% quota vacancies in the cadre of Junior Telecom Officers reflected in Annexure A5 and to grant the consequential benefits thereof,

(f) Direct the respondents to consider the applicants for promotion as Junior Telecom Officers on par with Phone Inspectors/Transmission Assistants/ Auto Exchange Assistants and Wireless Operators having the requisite qualification meant for direct recruitment and to grant the consequential benefits thereof; and

(g) Pass such other orders or directions as deemed just, fit and necessary in the facts and circumstances of the case.

6. Applicants in O.A.483/99 seek the following reliefs:

(a) Declare that the denial of consideration for promotion the applicants to the cadre of Junior Telecom Officers is highly arbitrary, discriminatory and unconstitutional,

(b) Call for the records leading to the issue of Annexures A3 and A4 and quash the same to the extent they deny consideration to the applicants for promotion as Junior Telecom Officers on par with Telecom Technical assistants,

(c) Call for the records leading to the issue of Annexure A5 and quash the same to the extent it denies consideration to the Senior Telecom Operating Assistants for promotion to the post of Junior Telecom Officers against 35% quota,

(d) Declare that the applicants are eligible to be considered for promotion as Junior Telecom Officers on par with Telecom Technical Assistants against 35% quota vacancies,

(e) Direct the respondents to consider the applicants for promotion against 35% quota vacancies in the cadre of Junior Telecom Officers reflected in Annexure A5 and to grant the consequential benefits thereof; and

(f) Pass such other orders or directions as deemed just, fit and necessary in the facts and circumstances of the case.

7. Applicants in O.A.534/99 seek the following reliefs:

(i) To call for the records relating to Annexures A1 to A3 and to declare that the denial of consideration for promotion to the applicants to the cadre of JTOs is highly arbitrary, discriminatory and unconstitutional,

(ii) To declare that the applicants are also entitled for consideration for promotion to JTOs in the 35% qualifying Screening Test meant for departmental candidates on par with TTAs,

(iii) To direct the respondents to consider those Sr.TOAs who are having the qualification prescribed for direct recruitment as a Walk-in Group and grant them promotion to the cadre of JTOs as has been done in the case of PIs/AEAs/WOs, etc.,

(iv) To issue such other appropriate orders or directions this Honourable Court may deem fit, just and proper in the circumstances of the case; and

(v) To grant the costs of this Original Application.

8. Applicants in O.A.544/99 seek the following reliefs:

"(i) To call for the records relating to Annexure A1 to A3 and to declare that the denial of consideration for promotion to the Applicants to the Cadre of JTOs is highly arbitrary, discriminatory and unconstitutional.

(ii) To declare that the applicants are also entitled for consideration for promotion as JTOs in the 35% qualifying Screening Test meant for Departmental candidates on par with TTAs.

(iii) To declare that the exclusion of Sr. TOSS from the Feeder category for promotion to the Cadre of JTOs from the 35% quota in Annexure A1 is illegal, arbitrary and violative of Articles 14 and 16 of the Constitution of India and to quash Annexure A1 consequent to the above declaration.

(iv) To direct the Respondents to consider those STOAs who are having the qualification prescribed for direct Recruitment as a Walk-in-Group and grant them promotion to the cadre of JTOs as has been done in the case of PIS/AEAs/WOS etc.

(v) To issue such other appropriate orders or directions this Hon'ble Court may deem fit just and proper in the circumstances of this case; and

(vi) To award costs of this Original Application."

9. Applicants in O.A.641/99 see the following reliefs:

"(i) To declare that exclusion of Senior Telecom Operating Assistants from the feeder category for promotion to the Cadre of Junior Telecom Officers from the 35% quota in Annexure A1 is illegal, arbitrary and violative of Articles 14 and 16 of the Constitution of India and to quash Annexure A1 consequent to the above declaration,

(ii) To call for the records relating to Annexure A1 to A3 and to declare that the denial of consideration for promotion to the Applicants to the Cadre of Junior Telecom Officers is highly arbitrary, discriminatory and unconstitutional,

(iii) To declare that the Applicants are also entitled for consideration for promotion as Junior Telecom Officers in the 35% qualifying Screening Test meant for Departmental candidates on par with Telecom Technical Assistants,

(iv) To direct the Respondents to consider those Senior Telecom Operating Assistants who are having the qualification prescribed for direct Recruitment as a Walk-in Group and grant them promotion to the Cadre of Junior Telecom Officers as has been done in the case of PIs/AEAs/WOs, etc,

(v) To issue such other appropriate orders or directions this Honourable Tribunal may deem fit, just and proper in the circumstances of the case; and

(vi) To award costs of this Original Application."

10. Applicants in O.A.673/99 seek the following reliefs:

(i) To declare that the provisions in column No.12 of Schedules to Junior Telecom Officers Recruitment Rules 1996, to the extent it excludes Senior Telecom Office Assistants with prescribed qualification for direct recruitment as Junior Telecom Officers, from the feeder category of Junior Telecom Officers for appointment by transfer/promotion is ultravires Article 14 and 16 of the Constitution of India,

(ii) To direct the respondents to consider the applicants for appointment by transfer/promotion as Junior Telecom Officers against the whole 50% vacancies of Junior Telecom Officers, along with others eligible without discrimination,

(iii) Grant such other reliefs as may be prayed for and the Court may deem fit to grant; and

(iv) Grant tea costs of this Original Application.

11. Applicants in O.A.687/99 seek the following reliefs:

(a) Declare that the denial of consideration for promotion to the applicants to the cadre of Junior Telecom Officers is highly arbitrary, discriminatory and unconstitutional,

(b) Call for the records leading to the issue of Annexures A3 and A4 and quash the same to the extent they deny consideration to the applicants for promotion as Junior Telecom Officers on par with Telecom Technical Assistants,

(c) Call for the records leading to the issue of Annexure A5 and quash the same to the extent it denies consideration to the Senior Telecom Operating Assistants for promotion to the post of Junior Telecom Officers against 35% quota,

(d) Declare that the applicants are eligible to be considered for promotion as Junior Telecom Officers on par with Telecom Technical Assistants against 35% quota vacancies,

(e) Direct the respondents to consider the applicants for promotion against 35% quota vacancies in the cadre of Junior Telecom Officers reflected in Annexure A5 and to grant the consequential benefits thereof,

(f) Direct the respondents to consider the applicants for promotion as Junior Telecom Officers on par with Phone Inspectors/Transmission Assistants/Auto Exchange Assistants and Wireless Operators having the requisite qualification meant for direct recruitment and to grant the consequential benefits thereof; and

(g) Pass such other orders or directions as deemed just, fit and necessary in the facts and circumstances of the case.

12. Respondents have filed detailed reply statements.

13. After having argued the matter at length by the learned counsel for the applicants, learned counsel appearing for the official respondents drew our attention to the order of the Bangalore Bench of this Tribunal in OA 235/99 (M.G.Balaji Rao & 3 others Vs. Secretary, Department of Telecommunications, New Delhi) and another. The Bangalore Bench of this Tribunal in OA 235/99 has stated thus:

"3. In O.A.15 of 1998 the applicants therein who also belong to Senior TOA Cadre, had sought for a direction that their cadre should also be included in the 35 per cent quota. That application was considered along with another O.A. No.73 of 1997. In O.A.No.73 of 1997 this Bench has discussed various aspects and has held that it is the prerogative of the Government to decide as to which cadres should be made the feeder cadre to a promotional post and as to what eligibility conditions should be imposed in respect of each cadre and that the Tribunal cannot interfere with that policy decision taken by the department nor can any direction of the nature sought for be given by the Tribunal. It was also pointed in the order in O.A.No.15 of 1998 that the recruitment rules for the various categories are different and that all those cadres cannot be treated as equal cadres for the purpose of promotion to the higher post. By the mere fact that prior to the new Rules, TTAs had also been included in the 15 per cent quota along with the cadre of senior TOA, the applicants cannot claim a right to be included in the same quota in which the TTAs have been included in the new Rules. In O.A. No.15 of 1998 we gave opportunity to the applicants therein to approach the department if

they have a claim to be included in 35 per cent promotional quota either under clause (a) or under clause (b) and that it would be for the department to consider their grievance and take such decision as is appropriate. Giving that liberty, the prayer sought for by the applicants in that application was refused. The view we have taken in the earlier case is that the cadre of Senior TOA and the other cadres having separate recruitment Rules, senior TOA cadre cannot claim parity with the other cadres. The fact that the strength of the Senior TOA cadre is more than the strength of the TTA cadre would not be relevant while determining the validity of the Rules."

14. We are in respectful agreement with the order of the Bangalore Bench of the Tribunal.

15. Learned counsel appearing for the applicants submitted that the applicants may be permitted to submit representations to the Secretary, Department of Telecommunication, New Delhi in respect of their grievance.

16. Accordingly, all these Original Applications are disposed, granting liberty to the applicants to submit representations to the Secretary to the Government of India, Department of Telecommunications, New Delhi, if they are so advised. We hope that the Secretary, Department of Telecommunications will consider the representations of the applicants if received with all the seriousness those representations deserve. No costs.
