HON'BLE MR. A.M. SIVADAS, JUDICIAL MEMBER

The applicant seeks to direct the respondents to include his name at the appropriate level in the divisional list of retrenched Casual Labourers belonging to Civil Engineering Department of the Southern Railway, Trivandrum Division and to grant him consequential benefits thereof.

2. When the OA was taken up, learned counsel appearing on both sides submitted that this OA may be disposed of by permitting the applicant to submit a representation to the




