

Applicants are Vocational Instructors/Maintenance Mechanics in the Model Industrial Training Institute, Calicut. Their grievance is that the benefit of a higher pay scale has not been granted to them on 1-1-1986. A similar matter was disposed of by the Madras Bench of this Tribunal in OA 567/91 with a direction to respondents therein to pass final orders on the representation of the applicants-association therein within three months. Applicants state that no orders have been passed in pursuance of that direction and that they are claiming similar benefits. Applicant-1 has made A-2 representation dated 1-9-1994 which is said to be under consideration. We permit other applicants also to make similar representations to first respondent within one month of today. The first respondent shall consider these representations and pass appropriate orders within three months from the date of receipt of the representations.

2. We dispose of the application as aforesaid. No costs.
