The applicants have filed this original  
application for the following reliefs:

- (i) to direct the respondents to implement  
Annexure.AI and regularise the service of  
the applicants as Safai Karmacharis as they  
are doing t/he above job ontinuously for the  
administration;
- (ii) to issue a declaration that the applicants  
are entitled for regular absorption in  
service under the Railway administration by  
implementing Annexure.AI eventhough they hve  
been engaged by private contractors; and
- (iii) to grant such other further reliefs that  
this Hon'ble Tribunal may deem fit and  
proper.

2. When the application came up for hearing today, learned counsel of the applicants states that the applicants may be allowed to withdraw this application with liberty to take up the matter before the proper forum prescribed under the Industrial Disputes Act. Liberty is granted and the application is dismissed as withdrawn. No order as to costs.
