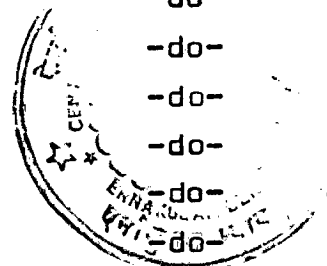

These applications having been heard on 12th November, 1996, the Tribunal on the same day delivered the following:

O R D E R

PV VENKATAKRISHNAN, ADMINISTRATIVE MEMBER

The Tribunal considered a similar issue in OA No.1149/94 and connected cases, and by order dated 29.6.95, the Tribunal directed respondent Administrator, Union Territory of Lakshadweep, to examine the cases of the applicants in those applications and take a fresh decision on whether they are entitled to pro-rata wages in terms of OM dated 7.6.88, and if the applicants in those applications were found eligible, to pay the difference between the pro-rata wages to which they

are entitled and the wages paid already. Applicants in these applications contend that respondents have carried out the directions of the Tribunal in OA 1149/94 and connected cases, but that the same relief has not been extended to the applicants in these applications on the ground that they were not parties in the cases mentioned above.

2. It is seen that the Tribunal has considered the issue in general and not with specific reference to the applicants in OA 1149/94 and has found that a broad comparison of the nature of the work done by the applicants in those applications and the work done by a regular employee has to be carried out to ascertain the eligibility of the applicants to get pro-rata wages in terms of the OM of 7.6.88. Such a direction cannot be taken as applicable only to the applicants who had come before the Tribunal in those applications, since it was a matter of interpretation of the OM referred to.

3. Respondents have stated in OA 636/96, 654/96, 637/96, 639/96 and 938/96 that the applications are barred by limitation. The relief sought for is in terms of the order of the Tribunal, which was pronounced in June, 1995, and the directions were implemented by the respondents by passing orders dated 16.11.95. These applications are well within time considering that date and we do not consider that these applications are barred by limitation.

4. Applicants in these applications are also entitled to the same relief as was granted to the applicants in OA 1149/94 and connected cases. We, accordingly, direct the respondent Administrator, Union Territory of Lakshadweep, to consider

the cases of applicants herein in terms of the directions of the Tribunal in OA 1149/94 in order to find out whether the applicants herein are also eligible for being paid pro-rata wages in terms of OM dated 7.6.88. A decision in this regard will be taken within four months of today and if the applicants are found eligible, arrears of wages shall be paid to them within three months of the date of the decision of the Administrator.

5. Applications are disposed of as aforesaid. No costs.
