Applicants who are Extra Departmental Mailman working in the Head Record Office, Ernakulam Division have filed this application for a direction to the Respondents 1 to 3 to take steps for filling up the existing vacancies in the cadre of Class IV (Group D) in Ernakulam Division and to promote the applicants to any of the existing vacancies.

2. When the application came up for hearing Shri C.Rajendran, SCGSC under instructions from the official respondents stated that steps have been taken for making recruitment to the vacancies in Group D cadre for the years 2000 and 2001 vide order No.Retctt/4-5/2001 dated 5.7.2002 and that for the vacancies of the year 2002 recruitment action would be taken shortly.

3. Taking note of the above submission made by the learned counsel for the respondents that the existing vacancies of Group D would be filled up without further delay, the application is disposed of directing the respondents to keep up their undertaking and to make recruitment to Group D posts in the Ernakulam Division considering the applicants in accordance with the rules.
