The applicant ^{who} ~~is~~ an aspirant for selection and appointment to the post of Extra Departmental Sub Post Master, Kurichi Post Office has filed this application for a declaration that the applicant is entitled to be considered for selection to the vacancy of Extra Departmental Sub Post-Master, Kurichi Post Office alongwith the candidates sponsored by the Employment Exchange, notwithstanding the fact that his name has not been sponsored by the Employment Exchange. The applicant submits that he has filed an application before

the first respondent on 12.3.98 (Annexure.A2).

2. When the application came up for hearing today, learned counsel appearing on behalf of the respondents states that in view of the ruling of the Hon'ble Supreme Court in Excise Supdt. Malkapatnam, Krishna Dist. A.P. Vs. K.B.N. Visweswara Rao and others (1996) 6 SCC 216, the respondents would consider the candidature of the applicant also for selection and appointment to the post of Extra Departmental Sub Post Master, Kurichi P.O.

3. In the light of the submission of the learned counsel for the respondents and as agreed to by the learned counsel for the applicant, we dispose of this application with a direction to the first respondent to consider the candidature of the applicant as valid for selection and appointment and to consider his name for selection and appointment to the post of Extra Departmental Sub Post Master, Kurichi Post Office, though his name may not be sponsored by the Employment Exchange.

4. Learned counsel for respondents undertakes to intimate the department of this order forthwith. No order as to costs.
