2. It is also submitted that respondents No.4 to 7 are being considered in the light of the judgement dated 21st May 2007 passed in Annexure R.4

3. In the light of the submissions made by Mr. N. Anilkumar, Sr. PCGC that they will abide by the age limit prescribed by Annexure A.1 and in the light of the judgement of the Hon'ble High Court dated 21.5.2007 nothing remains for consideration in this case.
