PV VENKATAKRISHNAN, ADMINISTRATIVE MEMBER

Applicant is aggrieved by Al order dated 25.3.1995 by which  
he was transferred from Trivandrum Division to Panaji Division. Appli-  
cant contends that the impugned orders are in violation of the


guidelines A2. He prays that the impugned orders be quashed.

2. It is now well settled that the Tribunal does not enforce the guidelines issued in respect of any transfer policy. Applicant states that he has not been relieved yet. He has made a representation A3 dated 29.3.1995 which according to him has not been disposed of. Counsel for applicant submits that applicant may be permitted to make a detailed representation. He may do so within one month from today to the 3rd respondent. If such a representation is received, 3rd respondent shall consider the request made by the applicant along with A3 and pass appropriate orders. Till such time as the further representation, if made, is disposed of, the impugned order A1 will be kept in abeyance in so far as it relates to the applicant.

3. Application is disposed of accordingly. No costs.
