

The application having been heard on 27.5.2005 and the Tribunal on the same day delivered the following:

ORDER

HON'BLE MR.H.P.DAS, ADMINISTRATIVE MEMBER

The learned counsel for the respondents submitted that since Annx.A1 orders were addressed to the Chief of the Army Staff therefore it was not automatically made applicable to the Naval establishment. He however submitted that the matter right now is under the active consideration of the Government to extend the facility to the Naval establishment. The learned counsel for the applicants submitted that she would be satisfied if the matter is favourably considered and sought the liberty of the Court to approach again if not satisfied with the disposal. I find from Annx.R3 (A) and Annx.R3(B) that the matter has been under consideration of the Ministry of Defence and Ministry of Finance since 4.2.2004 and apparently no decision has yet been taken. It would be in the fitness of things, without observing on the merit of the claim, to direct the respondents to dispose of the matter within a time frame of 6 months from the date of issue of this order. The O.A is disposed of with the above orders.
