CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN:


Applicants claim, benefits granted to the applicants in O.A.383/91 and O.A. 2045/93. A fact adjudication must precede a decision. The competent authority must make a fact adjudication and ascertain whether applicants are similarly situated as the applicants in the two cases aforementioned, or whether there are any points of difference.

2. If the applicants are similarly situated, reliefs granted to the applicants in O.As. 383/91 and 2045/93 will be granted to applicants herein. A determination will be made by the competent authority within six months from today. Applicants will furnish details of their service to the competent authority within 15 days from today, failing which this order will stand recalled and the application will stand dismissed. We alert respondents to adhere to the time schedule.
2. Application is allowed with the aforesaid directions. No costs.
