O R D E R

CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN

Applicants who are Senior Accountants in the

Accountant General's Office seek an order:

"granting the scale of pay of Rs.1640-2900 at par with the scale of Central Secretariat Assistants etc."

Equal pay for equal work, is the principle pressed into service to lace the claim. Whether work is equal and whether the employees in question are similar, are matters for the administrative Government and policy makers to decide. It is not the function of the Court to pronounce on such matters. In State of U.P. and others Vs. J.P. Chaurasia, (AIR 1989 SC 19), the Court observed:

"the equation of posts or equation of pay must be left to the executive Government. It must be determined by expert bodies like the Pay Commission. They would be the best judge to evaluate the nature of duties and responsibilities of posts Court should not try to tinker with such equivalence unless it is shown that it was made with extraneous considerations."

Again in Union of India and others Vs. Shri Tojram Patashramji and others (C.A.No.233/91) referring to an order of the Central Administrative Tribunal, the Apex Court observed:


"It is a policy matter involving financial burden. No court or Tribunal should compel the Government to change its policy, involving expenditure."

We find a similar view taken in Federation of All India Customs and Central Excise Stenographers Vs. Union of India (AIR 1988 SC 1291). Still later in Union of India Vs. Secretary, Madras Civil Audit and Accounts Association, (1992 SCLJ 530), the Supreme Court struck the same note of caution. In this state of law, we do not think that it is in our province, to prescribe a scale of pay as prayed for.

2. The application is without merit and we dismiss the same. The dismissal of this application will not stand in the way of applicants, raising their grievances before the Vth Pay Commission. We record appreciation of the help rendered by Shri M.R.Rajendran Nair as Amicus Curiae. No costs.
