Applicants seek to direct the 3rd respondent to re-engage them in terms of the scheme for re-engagement and regularisation of retrenched casual labourers and also to direct the 2nd respondent to dispose of A1 and A2 representations made by the 2nd and 12th applicants and similar representations submitted by the other applicants.

2. When the OA was taken up, the learned counsel appearing for the applicants submitted that it is suffice to direct the 2nd respondent to consider and pass appropriate orders on A1 and A2 representations made by applicants 2 and 12 and similar representations submitted by the other applicants within a time frame.




received by the respondents from the remaining applicants within a period of three months from the date of receipt of a copy of this order.
