also are claimed. Respondent Divisional Personnel



2. After arguing the matter at some length, learned counsel for applicants sought permission to move the Chief Personnel Officer against A-9 order, well advisedly. We grant permission to applicants to move second respondent Chief Personnel Officer by appropriate representations. If representations are made by applicants, second respondent will examine them as also A-9 order, and pass appropriate orders thereon within four months from the date of receipt of the representations.

3. With the aforesaid directions, we dispose of the application, making it clear that we have not expressed any opinion on the merits. No costs.
