O R D E R


CHETTUR SANKARAN NAIR (J), VICE CHAIRMAN

Applicants seek a declaration that the training period is liable to be reckoned for purpose of granting increment. They seek a further declaration that fixation of a date in A-1 to A-3 for the purpose of granting increment is arbitrary. According to applicants their claims stand supported by an order of the Bangalore Bench of the Tribunal in O.A. 156/92. However, respondent Chief General Manager took a contrary view in A-9. If applicants are aggrieved, they may represent their grievances before first respondent and first respondent will pass a considered order on the representations as the issue involved is one of far reaching consequences for a large number of employees.

2. Standing counsel submits that he will forward a copy of the original application and a copy of this order to first respondent for compliance. We record the submission.

3. Original application is disposed of as aforesaid.
