The application having been heard on 4th April 1997,  
the Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR A V HARIDASAN, VICE CHAIRMAN

The grievance of the applicant is that though he is qualified to be considered for appointment as Extra Departmental Mail Carrier, Palluruthy Industrial Estate Post Office, his candidature has been rejected on the ground that his name has not been sponsored by the Employment Exchange. The order rejecting his candidature dated 31.3.1997 (Annexure-A4) is under challenge in this application.

2. When the matter came up for hearing, learned counsel for respondents submitted that in view of the decision of the Supreme Court in Excise Superintendent, Malkapatnam, Krishna District, Andhra Pradesh Vs. K.B.N. Visweshwara Rao and others, (1996) 6 SCC 216, respondents shall consider the

candidature of the applicant also for the selection, in spite of the fact that his name has not been sponsored by the Employment Exchange.

3. In view of the above submission made by the counsel at the Bar, we dispose of the application directing respondents to finalise the selection and appointment to the post of Extra Departmental Mail Carrier, Palluruthy Industrial Estate Post Office considering the candidature of the applicant also scheduled to be held on 7.4.1997, even though his name has not been sponsored by the Employment Exchange. No costs.
