HON'BLE MR. A.V. HARIDASAN, VICE CHAIRMAN

The grievance of the applicants who are working as Senior Personal Assistants, is that the respondents 1 to 3 are not selecting and appointing them to the post of Civilian Gazetted Officers and at the same time going on promoting five Office Superintendents Grade -I in violation of the statutory Recruitment Rules. Highlighting this grievance, the first applicant has made a representation to the Chief of Naval Staff, Naval Headquarters, New Delhi on 2nd December, 1998, but there is no response to this.


2. When the Original Application came up for hearing, the learned counsel on either side state that the application may be disposed of directing the applicants to make a representation projecting their grievances, jointly to the second respondent and directing the second respondent to consider the representation and give a speaking order within a stipulated time.

3. In the light of the above submissions, the application is disposed of permitting the applicants to

make a joint representation to the second respondent projecting their grievances in not being considered for promotion to the post of Civilian Gazetted Officer, within two weeks from today and directing the second respondent that, if such a representation is received, the same shall be considered and disposed of with a speaking order within a period of two months from the date of receipt of the representation.
