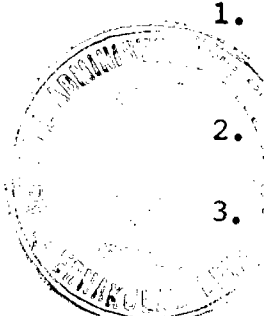

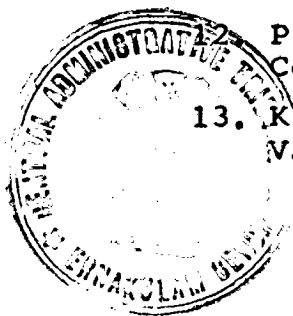

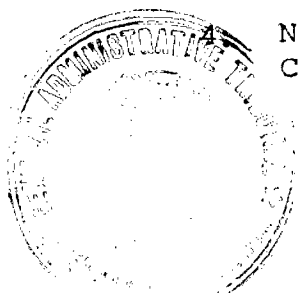

CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN:

The contentions raised in these 26 applications are similar, and so are the reliefs sought. Similar reliefs have been granted, in similar applications like, O.A.719/92, 836/93, 1862/93, 106/93 and 336/93 etc. It is said that Special Leave Petitions against some of the orders granting relief have been dismissed, and that Special Leave has been granted in some cases where relief was granted(O.A. 106/93 and 336/93).

2. Decisions of the Supreme Court lay down that grant of Special Leave or refusal of Special Leave will not be affirmation or negation, of the principle of law in a judgment against which leave was granted or refused. If authority is needed for this proposition, it is found in Late Nawab Sir Mir Osman Alikhan vs. Commissioner of Wealth-tax, Hyderabad (AIR 1987 SC 522); Daryao and others vs. State of U.P. and others (AIR 1961 SC 1457). In the Supreme Court Employees Welfare Association vs. Union of India and others (AIR 1990 SC 334), the Apex Court reaffirmed the position, and pointed out that Article 141 of the Constitution would be attracted, only when a declaration of law is made by the Supreme Court.

3. The Supreme Court has not made any declaration of law contrary to the law laid down by the different Benches of this Tribunal. We therefore follow the precedents and allow the applications and, direct respondents or such competent authority, to grant relief on family pension including arrears, to applicants within three months from today. In the event of the Supreme Court declaring the law to the contra, applicants will repay the amounts received by them. Parties will suffer their costs.
