to direct the first respondent to consider and dispose A-2


representation filed by the applicant and similar representations submitted by the remaining applicants.

2. When the O.A. was taken up, learned counsel appearing for the applicants submitted that it is suffice to direct the first respondent to consider and dispose of by a speaking order A-2 representation submitted by the first applicant and similar representations submitted by the remaining applicants within a time frame. Learned counsel appearing for the respondents submitted that there is no objection in adopting such a course.

3. Accordingly, the first respondent is directed to consider and pass a speaking order on A-2 representation submitted by the first applicant and similar representations submitted by the other applicants, within three months from the date of receipt of a copy of this order.

4. The Original Application is disposed of as above.
